IMPORTANT NOTICE - WASHINGTON WATER

Washington Water Service Company ("WWSC") has filed for approval from the Washington Utilities and Transportation Commission ("UTC") to decrease revenues needed to provide a reliable, high-quality water supply. The filing requests a decrease of \$625,101 in annual revenue, which is a 4.66% decrease from 2020. If approved, the new rates would become effective October 15, 2021.

WWSC's last general rate increase was effective December 1, 2018 and was based on 2017 capital and operating expenses. Since 2017, WWSC has made numerous water system upgrades at a cost of \$8.0 million, including:

- Consolidation of Seacliff and Peacock Hill water systems, involving 1,700 linear feet of 8" pipeline. The interconnection provides for increased reliability between the first and third largest systems.
- Customer billing software upgrade providing improved customer service and technical capabilities.
- Improvements in water quality due to treatment plant upgrades.
- Deployment of Geographic Information System (GIS) mapping and operations manuals to field teams.
- Replacement of well infrastructure to improve reliability and efficiency of water supply.

The filing reflects increases in materials, equipment, depreciation expense due the addition of new facilities, and increases in wages and healthcare costs. In the face of rising costs, we have worked diligently to control expenses wherever possible to help keep water rates affordable. The main factor driving the decrease in rates is the acquisition of the East Pierce system in 2020, which allows for costs to be spread over a larger number of customers.


