

## Schedule 60 COMPANY OPERATED ELECTRIC VEHICLE CHARGING STATION SERVICE

#### AVAILABLE:

In all territory served by the Company in the State of Washington.

## APPLICABLE:

To electric vehicle charging service provided from Company operated electric vehicle charging stations.

#### BILLING:

The Company may bill any individual that utilizes a Company operated electric vehicle charging station for the purpose of recharging the battery of an electric vehicle at the rates described below:

For stations under 19.2 kW (Level 2):	12¢ per kWh
For stations over 19.2 kW (DC Fast Charging):	39¢ per kWh

Additionally, the Company may include an idle fee if the individual occupies the charging service for more than 10 minutes after the completion of the recharging event. The Company shall base this fee on a rate of 40¢ per minute.

## **PROVISIONS**

- 1. The Company may apply additional service fees based on the siting location of the charging station.
- 2. The operation, repair, and maintenance of electric vehicle charging stations on this rate schedule will be the responsibility of the Company.
- 3. The Company will repair inoperable electric vehicle charging stations as soon as reasonably possible during regular business hours or as allowed by the Company's operation schedule and requirements, provided the Company receives notification from a customer or member of the public by notifying Pacific Power's Customer Service (1-888-221-7070).
- 4. The Company may, at its discretion, install, relocate, modify, or remove electric vehicle charging stations. Potential modifications to Company operated electric vehicle charging stations may include adding, removing, or changing available electric vehicle supply equipment.

#### RULES AND REGULATIONS

Service under this Schedule is subject to the General Rules and Regulations contained in the tariff of which this Schedule is a part and to those prescribed by regulatory authorities.
