Description of amendment:

Amends the agreement reflecting implementation of the FCC’s Forbearance Orders as provided in the Memorandum Option and Order, WC Docket Nos. 18-141 et al. (rel. Aug. 2, 2019) and Report Order on Remand and Memorandum Opinion Order, WC Docket Nos. 18-141 et al. (rel. July 12, 2019).

The amendment amends the interconnection agreement first accepted by the Commission on 1/08/2003 (date) in WUTC Docket No. UT- 023067 (original docket number).

Company A represents that the amendment does not discriminate against non-party carriers, that it is consistent with state and federal law, and that it is in the public interest. By virtue of Company B’s signature on the amendment, Company A believes that Company B agrees with these representations.
