

AMENDMENT 6 TO

THIS AMENDMENT NO. 6 ("Sixth Amendment") by and between **Qwest Communications Corporation** ("QCC" or "Qwest") and **Qwest Corporation** ("QC" or "Qwest") and the **State of Washington, Department of Information Services** ("Customer") hereby amends the Supplemental Work Order 04-01 to Contract Number T02-TSD-319 for Advanced Transport Services - retained under Content ID 060851 between Customer and Qwest, as may have been previously amended (the "Agreement"). Except as set forth in this Sixth Amendment, capitalized terms will have the definitions assigned to them in the Agreement. This Amendment supersedes and supplants the Amendment stored under Content ID Number 219661.

1. **Modifications.** Qwest and Customer wish to amend the Agreement to revise the Traffic Destination point of each location outlined in the table below. Customer will pay for all charges associated with such modification. Qwest's records will document the actual date of installation.

2. The monthly recurring charges (MRC) and non-recurring charges (NRC) above supersede the charges for the subject location(s) previously agreed to in the Contract including any prior modifications. The monthly recurring amounts shown above are not necessarily the total, cumulative charges for all Service under the Site Agreement. Any new nonrecurring charges are in addition to any previously agreed to such charges in the Site Agreement.


3. This Sixth Amendment renews the term of the locations listed above for an additional forty-eight (48) months from the date Service is available to DIS at the locations listed in the above table, as evidenced by Qwest records ("Renewal Term").

4. **Miscellaneous.** This Sixth Amendment will be effective as of the date it is executed by Qwest after the Customer's execution (the "Sixth Amendment Effective Date") and be deemed incorporated by reference into the Agreement. All other terms and conditions in the Agreement will remain in full force and effect and be binding upon the parties. This Sixth Amendment and the Agreement set forth the entire understanding between the parties as to the subject matter herein, and in the event there are any inconsistencies between the documents, the terms of the Agreement will control.
