The Company has investigated this matter and has determined that due to an internal processing error, the account for telephone number (425) 778-3964 was assessed incorrect rates for Excel's long distance service from February 18, 2004 through April 17, 2004. The Company sincerely apologizes for this error and regrets any inconvenience this matter may have caused. Please note that Excel's default long distance service is billed at a rate of \$0.05 per minute with a \$0.25 connection charge per call.
