Dear Mr. Gibbs:

I am the attorney for Western Village Mobile Home Park with regard to its dispute with Puget Sound Energy about maintenance responsibility for PSE's underground service hardware. Please direct all further contact and communication regarding this matter to me.

We received your letter dated July 8, 2005 today, and it purports to require that we agree to repair PSE's service wire by today.

If PSE's service requires repair, then PSE should complete the repair. While the tariff provision you cite may be applicable to other residential service, it is not applicable to service within a manufactured home community. Indeed, I have successfully litigated this very issue with a telecommunications provider before the Washington Utilities and Transportation Commission. If necessary, Western Village has authorized me to complete that same complaint process which will result in a hearing before an administrative law judge unless other arrangements are made.

Please complete whatever repairs you believe are necessary to provide service to your customers. However, in doing so, Western Village assumes no responsibility for any expense incurred by PSE.
