THE PARTIES' SETTLEMENT  
STATUS REPORT

11 SEFNCO Communications, Inc. ("SEFNCO") and the Staff of the Washington Utilities  
12 and Transportation Commission ("Staff") (collectively "the Parties") submit this report on the  
13 status of their settlement. On April 24, 2018, the Parties notified the Washington Utilities and  
14 Transportation Commission ("Commission") that a settlement had been reached in principle.  
15 That same day, Judge Chartoff issued a notice requiring the filing of the settlement documents  
16 or a status report of negotiations by May 11, 2018.

17 The Parties are still fully committed to the settlement reached in principle, but need one  
18 more week to finalize the documentation. The Staff worked diligently to draft both the  
19 Settlement Agreement and the Settlement Narrative. Counsel for SEFNCO received the drafts  
20 of these documents on the afternoon of May 9, 2018. In addition to the undersigned counsel,  
21 SEFNCO has executives in its local office, executives at its corporate office, and another  
22 attorney who all need to review the documentation before signing off on its final form. Given  
23 that many of the aforementioned individuals live on the east coast, it was simply not possible to  
24 have this finalized by May 11, 2018. SEFNCO expects to have some minor proposed changes

1 to certain language in the documents, and will provide those to the Staff as soon as possible.  
2 The Parties are committed to finalizing and filing all settlement documentation by  
3 May 18, 2018.
