- 2) Formerly had "satellite" pager but returned it when I found out it was actually FM radio based and didn't work in Skyko 2.
- 3) Formerly had cellular wireless IP service but discontinued it because it didn't work in Skyko 2 and was unreliable in and around the town of Index
- 4) Have a radio-telephone but discontinued using it because it was very unreliable.
- 5) Contacted Verizon several times when we first moved here to ask about getting phone service, eventually was contacted by a Mr. Fischer? from Verizon who said that it could be done if I paid for it myself and if payment was guaranteed by my employer. There was never any firm estimate but the dollar amount that was suggested was in the hundreds of thousands of dollars, which I could not afford.
- 6) Made inquiries with Snohomish County about running my own line up Index-Galena Road. The county representative said that I wouldn't be allowed to use the county right of way since I wasn't a public utility.
