- Q. Please state your name and business address.
- A. My name is Daniel A. Doyle. My business address is 10885 NE Fourth Street,
 P.O. Box 97034, Bellevue, WA 98009-9734. I am Senior Vice President and
 Chief Financial Officer of Puget Sound Energy ("PSE").
- Q. By whom are you employed and in what capacity?
- A. I am PSE's Senior Vice President and Chief Financial Officer.
- Q. What are your duties as Senior Vice President and Chief Financial Officer?
- A. As Senior Vice President and Chief Financial Officer, I have the overall responsibility for the financial management and financial health of PSE, which includes communicating with the financial community, overseeing financial strategy and financing programs, and overseeing PSE's financial regulatory strategy before the Washington Utilities and Transportation Commission and before the Federal Energy Regulatory Commission.
- Q. Briefly describe your education and relevant employment experience.
- A. I have a Bachelor of Arts degree in Accounting from Michigan State University. I also have a Masters of Business Administration in General Management and Technology from Rensselaer Polytechnic Institute in Troy, New York.

I joined PSE on November 28, 2011, with more than 25 years of experience in the utility and electric transmission industry. Prior to joining PSE, I was President and Chief Executive Officer of Wisconsin Sports Development Corporation in Madison, Wisconsin. From October 2000 to July 2009, I served as Vice President, Chief Financial Officer, and Treasurer of American Transmission Company LLC ("ATC"). As a Member of the leadership team and Officer at ATC's first multistate, transmission-only utility, I was responsible for overseeing the financial, information technology and human resource functions.

Prior to ATC, I was employed by Alliant Energy Corporation ("Alliant Energy") and its various predecessor companies. I held various positions at Alliant Energy, including Controller and Treasurer, Vice President of Finance, Vice President of Power Production and Wholesale Services, and Vice President of Manufacturing and Energy Portfolio Services. During my tenure at Alliant Energy, I was responsible for accounting and financing matters and strategic financial planning matters, including merger analysis, dividend policies and asset rationalization initiatives.
