The Commission's Order 08/06 authorized a revenue requirement increase of \$21.1 million to the Company's base rates for Rate Year 2, subject to a revision to modify the net power cost (NPC) forecast. Consistent with the Order, the Company has updated the net power cost forecast, and this results in a revised revenue requirement increase of \$15.8 million. The proposed tariff sheets support the updated revenue requirement increase, including an update to Schedule 92, Temporary Coal Cost Adjustment, which is a tracker established in the Settlement Stipulation for recovery of non-NPC costs associated with coal-fired facilities. In compliance with Washington law, all coal-resource expenses and capital recovery will be removed from rates, which will lower the recovery of Schedule 92 to decommissioning costs offset by the amortization of deferred fly-ash revenues. In April of 2026, once the deferred fly ash revenues are fully amortized, another compliance filing will need to be submitted to remove those revenues from Schedule 92.

Enclosed as Attachment B is the estimated effect of the price changes, including billing determinants and monthly billing comparisons. The average residential customer using 1,200 kWh per month will see an increase of \$5.94 per month. Attachment E provides an updated calculation of the Low-Income Bill Assistance discount.
