- ¹ On April 19, 2005, Inland Telephone Company (Inland Telephone) filed with the Commission revisions to its currently effective Tariff WN U-5. The stated effective date is July 1, 2005.¹ Inland Telephone requests that territory be added to its service area north of the Roslyn exchange, and that territory be removed from its service area comprised of the Suncadia Resort on the southern edge of the Roslyn exchange. On June 29, 2005, the Commission entered Complaint and Order No. 01 in this proceeding suspending Inland Telephone's proposed tariff revisions.
- 2 The Commission will hear this matter pursuant to Part IV of chapter 34.05 RCW pertaining to adjudicative proceedings, including but not limited to RCW 34.05.413, RCW 34.05.422, RCW 34.05.431, RCW 34.05.440, RCW 34.05.449, and RCW 34.05.452. The Commission has jurisdiction over this matter pursuant to Title 80 RCW, having legal authority to regulate the rates, services, and practices of telecommunications companies providing service within the state of Washington. Statutes involved, in addition to those previously cited, include those within chapters 80.01 RCW, 80.04 RCW and 80.36 RCW relating to rates,

including but not limited to RCW 80.01.040, RCW 80.04.020, RCW 80.36.090, RCW 80.36.230, and RCW 80.36.300. Rules involved include those within chapters 480-07 WAC, and 480-120 WAC.

The ultimate issues include whether the proposed tariff revisions are fair, just, reasonable, sufficient, and in the public interest. In accordance with the provisions of RCW 80.04.130, the burden of proof to show that the proposed tariff revisions are just and reasonable shall up upon the respondent.

4 THE COMMISSION GIVES NOTICE That a prehearing conference in this matter will be held at 2:30 p.m., on Thursday, August 11, 2005, in Room 108, First Floor, Chandler Plaza Building, 1300 S. Evergreen Park Drive S.W., Olympia, Washington.

- 6 Petitions to intervene should be made in writing at least three business days prior to the date scheduled for the prehearing conference, as required in WAC 480-07-355(a). The Commission will consider petitions to intervene made orally during the conference, but strongly prefers written petitions to intervene. In addition, party representatives must file notices of appearance with the Commission, as required by WAC 480-07-345(2), no later than the day prior to the conference. If any party or witness needs an interpreter or other assistance, please fill out the form attached to this notice and return it to the Commission. The time and place for any evidentiary hearings will be set at the prehearing conference, on the record of a later conference or hearing session, or by later written notice.

- THE COMMISSION GIVES NOTICE that any party who fails to attend or participate in the prehearing conference set by this Notice, or any other stage of this proceeding, may be held in default in accordance with RCW 34.05.440. The parties are further advised that the sanction provisions of WAC 480-07-450 are specifically invoked.
