Have you reviewed the pre-filed testimony prepared by Alex Funderburg Jr. in support of BNSF's opposition of the proposed modifications at the 9<sup>th</sup> Street rail crossing?

## What comments do you have in response to the testimony of Alex Funderburg Jr.?

Mr. Funderburg made the statement that the "proposed four-gate roadway system design is not necessary or required under Federal Railroad Administration regulations, including 49 CFR Subtitle B, Chapter II, Part 222". I acknowledge that Appendix A of this chapter lists both a "FourQuandrant Gate System" and "Gates With Medians or Channelization Devices" as Approved Supplementary Safety Measures (SSMs).

Appendix B – Alternative Safety Measures, states that "If there are unique circumstances pertaining to a specific crossing or number of crossings which prevent SSMs from being fully compliant with all of the SSM requirements listed in appendix A, those SSM requirements may be adjusted or revised. In that case, the SSM, as modified by the public authority, will be treated as an ASM under this appendix B, and not as a SSM under appendix A." It further states "If one or more of the requirements associated with an SSM as listed in Appendix A is revised or deleted, data or analysis supporting the revision or deletion must be provided to FRA for review."

To date, the City has not been made aware of an FRA review of the change proposed by BNSF and as such does not feel comfortable making the design change.
