Rachel,

I did receive and review your request the week before last. Thank you for checking.

Following is our response to your questions.

Irrigation water supplied by SVWW <u>does not</u> flow through the customer's domestic water service meter. Domestic service lines and irrigation service lines operate <u>independently</u>; each service line is brought to the service address with an isolated service connection.

Annual Irrigation Assessments are billed based on the base rate and per acre charge for each lot. There is no consumption tracked nor billed for irrigation.

I will verify the contractual obligations and forward that to you.

Summit View Water Works purchases power from Benton PUD; this is the only source of power used to operate SVWW.

SVWW purchases irrigation water from Badger Mountain Irrigation District (BMID) to meet demand during the irrigation season.

The newest loans for infrastructure total over \$1.1 Million. This far exceeds the available bank balance. It has been the approved practice to depreciate infrastructure costs over time through amortization.

In addition, we keep in mind the seasonality of irrigation revenue and the unknown expenses that may arise for either the domestic or irrigation systems. An annual repair or equipment replacement can easily exceed \$50K in a season.

Rachel,

In preparation of requesting the rate change to our effective dates to February 1, 2024 of our pending filing, we want to make the UTC aware of the effect this has on our billing and in turn our customers and the onerous position this creates.

The domestic change effective date will happen as it becomes scheduled without an occurrence. Domestic services are billed monthly.

However, SVWW bills Irrigation services as an annual assessment. As indicated in our tariff, we bill in March and June with payment due dates in April and July respectively. (We follow suit with other irrigation agencies/districts across the Western United States, in accordance with RCW 87.03. This timing was determined by the Company and Commission staff (Jim Ward), while establishing the Companies first Tarif (2005 - 2010).)

When SVWW originally filed the rate case earlier in 2023, we sought completion prior to the end of the 2023 year. We took into account the time needed to supply data requests and answer questions, based on our prior filing, in addition to the processing time of sixty days we offered to the UTC.

With the latest extension of an effective date of February 1, 2024, we bring to the UTC's attention that any date beyond that puts the billing of our Annual Assessments in a difficult position.

We will already be working through prorating two different rates for any homes closing in January. We will potentially record losses for those property closing, since the buyer and seller will be negotiating two different rates in their closing process.

We would ask the UTC's support in reaching clarity and completion so that our irrigation billing process may resume in 2024 with no additional obstacles.

We also ask for the UTC's consideration of maintaining the two separate workbooks. These were initially set up with Jim Ward's guidance when our tariff began and maintained through our last rate case. The two different services each have their own nuances; many of these are addressed in our communications. There was concern that the original irrigation workbook had been broken due to a formula error. The same is true of the newer workbook version. There are specifics that apply to only one service or the other; it does not appear that the new workbook version can stand alone without editing. To support the work as originally designed, we believe the use of the individual workbooks serves the needs of our customers best.

The Company believes it and the customers are best served via separate workbooks, as future rate cases may only be needed for either Domestic, or Irrigation, and not always both services will need adjustment.
