TO ALL INTERESTED PERSONS:

The Washington Utilities and Transportation Commission (Commission) proposes to adopt a new chapter in WAC 480 and revisions to WAC 480-107. The Commission provides interested persons with the opportunity to file written comments on the proposed rules and to participate in the formal rule adoption hearing scheduled for 1:30 p.m. on Tuesday, April 30, 2019.

On February 20, 2019, the Commission filed a Notice of Proposed Rulemaking (CR-102) with the Office of the Code Reviser. The proposed rules would update its rules for Public Utility Regulatory Policies Act, Obligations of the Utility to Qualifying Facilities. The Commission has reviewed comments on three sets of draft rules from stakeholders and now proposes rules subject to review and comment by interested persons. The proposed rules are available for inspection on the Commission's website at www.utc.wa.gov/161024. The CR-102 filing initiates the final part of the rulemaking process, which includes a written comment period, a public adoption hearing, and a decision by the Commission.

If you are unable to submit documents via the portal, you may submit your comments by email to the Commission's Records Center at records@utc.wa.gov or by mailing or delivering an electronic copy to the Commission's Records Center on a flash drive, DVD, or compact disc that includes the filed document(s). Comment submissions should include:

- The commenting party's name.
- The title and date of the comment or comments.
