NATURE OF PROCEEDING. Docket No. UW-040366 is a special proceeding convened by the Washington Utilities and Transportation Commission (Commission) pursuant to RCW 84.04.015 to determine whether Marbello Water Company (Marbello or Company) is subject to regulation under Chapter 80.28 RCW and is performing any act requiring approval of the Commission without securing such approval.

Docket No. UW-0401181 is a proceeding to investigate Marbello's requested rate increase, filed on June 28, 2004 and suspended by the Commission at its open meeting on July 28, 2004.

- APPEARANCES. Richard Finnigan, attorney, Olympia, Washington, represents Marbello. Jonathan Thompson, Assistant Attorney General, Olympia, Washington, represents the Commission's regulatory staff ("Commission Staff" or "Staff").<sup>1</sup>
- BACKGROUND. A prehearing conference was convened on September 3, 2004 to allow the parties to present a settlement agreement for Commission consideration. However, the parties stated that they had been unable to reach full settlement. As a partial resolution, Staff agreed to file a motion to withdraw the complaint docket, UW-040366, on the ground that the initial rates filed by Marbello are fair, just, reasonable and sufficient. Staff will file its motion to withdraw the complaint on September 10, 2004. The parties agreed that they would proceed to litigate the company's subsequent rate case, Docket No. UW-041181, according to the schedule that follows:
