Dear Mr. King:

Enclosed under separate transmittal today by their accountants is a new general rate case filing by Waste Control, Inc. (“Waste Control” or “Company”). The Company is making this filing as authorized by Paragraph 27, Order 05 in Docket TG-131794 to preserve the temporary disposal rates subject to refund in the existing docket and includes the same disposal fee rate increase amount granted by Order 02 on November 27, 2013.

By this letter, Waste Control waives initial Commission consideration of this new filing at an Open Public Meeting and requests that the Commission immediately issue an order of suspension for investigation of the proposed tariff changes. The Company also asks that the Commission schedule a prehearing conference in the new docket as expeditiously as possible.

Additionally, the Company requests that the record in Docket TG-131794 be incorporated into the new docket so that efficiencies, references, and overall economies for all concerned in evaluating the financial issues raised by these filings can be preserved and enhanced. Enclosed in further support of the new filing is Supplemental Testimony on behalf of Jacqueline G. Davis, and Exhibit JD-11 (4/3/14) which attempts to address any and all additional direct evidence gathered on the part of the Company both in its original September 23 and February 18, 2014 case-in-chief filings in Docket TG-131794. Waste Control intends that the new filing, the record in Docket TG-131794, and this supplemental testimony and Exhibit JD-11 be considered the Company’s case-in-chief for the purpose of this new docket. The Company will be prepared to address any associated logistical issues at the prehearing conference in the new docket particularly whether the overall filing today, including all tariff pages, maps, customer notices, et al., from which Exhibit JD-11 is derived, should be marked as an
