On November 15, 2021, Puget Sound Energy (“PSE”) filed with the Washington Utilities and Transportation Commission (the “Commission”) a draft 2022 Request for Proposals for Distributed Energy Resources (“Draft 2022 DER RFP”) for approval by the Commission, pursuant to Order 05 in Docket UE-200413 and as specified in Chapter 480-107 WAC.
