Enclosed is the Company's application for a service agreement between Washington Natural Gas Company and The Boeing Company. The service agreement represents the culmination of successful negotiations between the two companies.

Washington Natural files herewith three copies of the application and requests that the Commission approve it as a special contract pursuant to the provisions of WAC 480-80-335. Accompanying the application as supporting schedules are copies of the contract itself and exhibits providing the documentation required by WAC 480-80-335(5).

All supporting schedules in this filing are proprietary in nature for both parties to the contract, and the Company claims confidentiality and protection from inspection or copying under WAC 480-09-015 and the underlying provisions of chapter 42.17 RCW and RCW 80.04.095. We further understand that, prior to any release of this material, Washington Natural Gas Company will be notified in order to allow the Company to invoke any and all statutory procedures for securing a court order protecting the material as proprietary and confidential.

The Company entered into the Agreement with The Boeing Company ("Boeing") which is subject to Commission approval prior to 16 The Agreement accompanies this Application as 17 implementation. confidential Exhibit "A". 18 19 Boeing requires gas service to conduct operations at 3. certain facilities ("the Boeing Facilities"). Boeing has secured 20 21 its own gas supplies for use at the Boeing Facilities. Boeing has 22 secured transportation capacity on Northwest Pipeline also 23 Corporation's pipeline facilities. 24 The gas which Boeing secures must be transported through 4. the Company's distribution system from an interconnection with the 25 pipeline facilities to points of delivery at the Boeing Facilities. 26 27 APPLICATION OF WASHINGTON NATURAL GAS COMPANY - 1 28

1 The gas must also be measured at or before the points of delivery.

2 5. The Company is willing to provide the services that Boeing requires. However, Boeing's service needs do not conform to 3 4 any Company tariff that is currently effective. Boeing and the 5 Company therefore negotiated the Agreement. In consideration for 6 the services offered under the Agreement, Boeing has agreed to an 7 initial Agreement term of 20 years. The Agreement will commence on the first day of the calendar month after the Commission approves 8 9 the Agreement as a special contract.

6. Boeing has further agreed not to bypass the Company's
distribution system for the duration of the initial Agreement term.
This is significant. Absent this commitment, the continuing
potential for bypass at the Boeing Facilities is very real. The
Agreement ensures that the Company will not lose its single largest
customer.

The Agreement does not result in discrimination between 7. 16 receiving like and contemporaneous service under 17 customers substantially similar circumstances. Boeing possesses specific 18 service needs at the Boeing Facilities. The Agreement responds to 19 these needs and provides the services which Boeing has requested. 20 No other customer of the Company receives this combination of 21 The Company and Boeing negotiated the 22 services at this time. Agreement because Boeing's service needs do not conform to any 23 applicable tariff of the Company, and because certain services 24 which Boeing desires are not specifically addressed in the 25 Company's tariff. 26
