NOTICE REVISING PROCEDURAL SCHEDULE (Settlement Hearing set for Monday, July 26, 2021, at 10 a.m.)

TO ALL PARTIES:

On March 25, 2021, the Washington Utilities and Transportation Commission (Commission) issued a Complaint Seeking to Impose Penalties; Notice of Prehearing Conference (Complaint) against Clutter, Inc. (Clutter or Company), which alleged that Clutter violated Washington Administrative Code (WAC) 480-15 a total of 390 times. The Complaint scheduled a prehearing conference on Tuesday, May 4, 2021.

On May 5, 2021, the Commission entered Order 02, Prehearing Conference Order; Notice of Hearing (Order 02) in this docket, which established a procedural schedule including an evidentiary hearing set for July 26, 2021.

On June 11, 2021, Commission staff (Staff) filed a letter in this docket to inform the Commission that Staff and the Company (collectively, the Parties) have reached a full settlement in principle and request that the Commission cancel the current procedural schedule.

On June 25, 2021, the Commission issued a Notice Suspending Procedural Schedule, which required the Parties to submit a proposal for a revised procedural schedule that allows for consideration of the settlement by July 2, 2021.

On July 2, 2021, the Parties filed a proposed revised procedural schedule that includes the following:
