- On August 31, 1999, U S WEST, Inc. and Qwest Communications International Inc. jointly filed an application requesting that the Commission issue an order disclaiming jurisdiction over the transaction, or in the alternative, approving the merger. The Commission granted the petition by order entered June 19, 2000.
- On January 31, 2002, Qwest petitioned the Commission to modify certain requirements of the Commission's Ninth Supplemental Order in Docket No. UT-991358 and to mitigate a portion of a credit due to customers under a provision of that Order relating to service quality.
- Qwest addresses one standard in the Service Quality Performance Program established in the Order, the standard entitled Repair Intervals for Out-of-Service Conditions. The Order allows Qwest to "petition the Commission for mitigation of the credit amounts that would otherwise be paid" and that the Commission "shall consider whether the assessment of credit amounts is due to unusual or exceptional circumstances for which the Company's level of preparedness and response was reasonable." Qwest seeks mitigation of the credit amount for this service quality performance standard for eight of twelve months in 2001, when it achieved performance at 99.5% or better, to reduce by \$666,667 the \$1,000,000 credit due for this element according to terms of the Order.
- Qwest also seeks modification of the Order regarding the standard addressing Repair Intervals for Out-of-Service Conditions, to provide for future credits only when it fails to achieve performance at 99.5% or better, in lieu of the 100% level provided by the Order.
- The hearing set by this notice is being held pursuant to Part IV of chapter 34.05 RCW pertaining to adjudicative proceedings, including but not limited to RCW 34.05.413, RCW 34.05.449, and RCW 34.05.452. The Commission has the authority to decide this matter pursuant to Title 80 RCW, having legal authority to regulate the rates,

services, and practices of electric utilities, and pursuant to chapter 80.08 RCW, concerning securities, and chapter 80.12 RCW, concerning transfers of property, mergers, and acquisitions. In addition to the foregoing, statutes and rules involved include those within chapters 80.04 and 80.36 RCW, and chapters 480-100, 480-143 and 480-146 WAC, and chapter 480-09 WAC. The issues involved include whether the Commission should grant the petition to modify the Ninth Supplemental Order and to mitigate credits due under its existing terms.
