Clallam and Jefferson Counties on one hand, and Seattle hotels and Tacoma hotels and Seattle cruise terminals on the other hand, with no service between Seattle hotels and Tacoma hotels and Seattle cruise terminals, and with closed door service between the indicated points.~~

~~BETWEEN: Kitsap County and Seattle and Tacoma hospitals, Amtrak stations, Greyhound station, cruise terminals, hotels, and the Seattle Tacoma International Airport with closed door service between Kitsap County and the indicate points in King and Pierce County.~~


