Please provide an updated analysis of PSE's expected transmission costs for the rate year based on the release of BPA's Draft Record of Decision in the BP-14 rate proceeding.

#### First Supplemental Response:

On July 24, 2013, the Bonneville Power Administration ("BPA") released the Administrator's Final Record of Decision ("ROD") in its 2014 Power and Transmission Rate Adjustment Proceeding ("BPA 2014 Rate Case"). Rate year transmission costs decreased \$3.1 million due to the Final ROD as compared to the estimated rates provided by BPA last November. Puget Sound Energy, Inc. ("PSE") plans to update rate year power costs for this change in its rebuttal filing due August 28, 2013.
