NOTICE OF OPPORTUNITY TO RESPOND TO PETITION FOR INTERLOCUTORY REVIEW OF ORDER 06 (Responses due by 5 p.m., April 29, 2024)

RE: Washington Utilities and Transportation Commission v. Puget Sound Energy, Docket UG-230393

TO ALL PARTIES:

On May 25, 2023, Puget Sound Energy (PSE or Company) filed with the Washington Utilities and Transportation Commission (Commission) revisions to its currently effective natural gas tariff WN U-2. PSE characterizes its filing as establishing a new tariff schedule, Schedule 141LNG – Liquefied Natural Gas Rate Adjustment, made pursuant to the Commission's final order in Dockets UE-220066 and UG-220067 (Final Order), PSE's last general rate case (2022 GRC). This new tariff schedule will allow PSE to recover the costs incurred with the development, construction, and operation of its Tacoma Liquefied Natural Gas (LNG) Facility.

On March 7, 2024, the Commission received a Public Records Act Request (Request) for confidential records submitted by Puget Sound Energy (PSE) to Commission staff (Staff) pertaining to this pending adjudication.

On March 8, 2024, the Commission issued a Notice Reopening Record for a Limited Purpose and Notice of Opportunity to Respond to Public Records Act Request (Notice). Pursuant to WAC 480-04-095(5)(c)(ii)(B), the Commission provided to PSE and other parties in this adjudication the opportunity to respond to the Request for confidential information and provide their respective positions on whether the disclosure of the requested records should be exempt.

On March 26, 2024, the Commission entered Order 06, Denying Public Records Act Request for Confidential Information.

On April 4, 2024, the original requestor filed a Petition for Review of Order 06 (Petition for Review). Pursuant to WAC 480-07-825(2)(c), any party to the adjudication may file a response

to a petition for review, and such responses must be filed within 10 days of the petition unless the Commission establishes a different deadline. It has come to the Commission's attention that the requestor may not have timely provided service of the Petition for Review to the parties, preventing them from submitting any timely response. We thus find good cause to extend the deadline for responses to April 29, 2024.

THE COMMISSION GIVES NOTICE That the Commission requires any responses to the Petition for Review, attached to this Notice, be filed no later than 5 p.m. on Monday, April 29, 2024.
