Enclosed please find for filing the Revised Direct Testimony of Kevin Woodruff on behalf of Public Counsel in this matter, pursuant to WAC 480-07-460(1)(b). The revisions are necessary to correct a factual error in Mr. Woodruff's testimony, i.e., the statement of Public Counsel's recommended power cost adjustments in system rather than Washington jurisdictional amounts. The revised testimony presents the recommended adjustments on a Washington jurisdictional basis, with relevant changes highlighted. There are no changes to Mr. Woodruff's exhibits, Exhibit Nos. (KDW-2) through (KDW-8).

Parties were orally advised early last week by the undersigned that the error had been identified and that revised testimony would be filed. Public Counsel will file revised workpapers for Mr. Woodruff under separate cover. Revised testimony of Public Counsel revenue requirement witness Hugh Larkin will also be filed shortly to reflect the revision in Mr. Woodruff's power cost adjustments.
