QWEST'S CERTIFICATION IN  
ACCORDANCE WITH THE FIFTH  
SUPPLEMENTAL ORDER

Qwest Corporation ("Qwest") hereby makes this filing in accordance with the requirements of the Settlement Agreement in this case, as adopted and approved by the Fifth Supplemental Order. As set forth in paragraph 7 of the Fifth Supplemental Order, the Washington Utilities and Transportation Commission ("Commission") imposed a penalty on Qwest of \$150,000 for violations of certain laws and Commission rule. Of that amount, \$50,000 was suspended for one year and will be mitigated to zero if Qwest files a certification of compliance with applicable law in accordance with paragraph 7, and if Staff has made no other allegations of violations relating to Qwest's Centrex services. Attached hereto is the required certification. Qwest further states that to its knowledge Staff has made no other allegations of violations relating to Qwest's Centrex service. Therefore, Qwest asks that the remaining penalty amount of \$50,000 be mitigated to zero.



1. My name is Teresa Taylor and I am an Executive Vice-President for Qwest. I make this declaration based on my own personal knowledge.

2. During the time period of March 2002 through March 2003, I was responsible for the Product Management organization for Qwest Corporation. That organization is responsible for the offering of Qwest's Centrex products. Employees responsible for formulating offers and/or promotions for Qwest's Centrex services reported to me during that time, either directly or indirectly.

I signed the Settlement Agreement approved by the Washington Utilities and Transportation Commission in Docket No. UT-011329, and have reviewed the Fifth Supplemental Order Approving and Adopting Settlement. Pursuant to paragraph 7 of the Fifth Supplemental Order, I certify that Qwest's offering and provisioning of its Centrex services from March 2002 through March 2003 was in compliance with the statutes and rules that were the subject of the Commission proceeding: RCW 80.36.150, RCW 8036.170, RCW 80.36.180, and WAC 480-80-330.
