

PSE's resource needs have seasonal variations throughout the year



Any resource acquisition recommendation will have considered three potential options (buy, build, or contract)

Status of Discussions with Developers

Solicitation letter mailed out September 13, 2002

- 71 recipients
- 39 interested projects
- 13 prioritized project opportunities

Additional face-to-face discussions being held with prioritized project opportunities

- Six projects (four companies) discussed to date
- Four projects (three companies) scheduled week of January 6th ;
- Three project (three companies) scheduled week of January 13th

Top ~3 candidate projects should be determined by end of January

- Due diligence would commence thereafter

Status of PPA Solicitation

Solicitation letters mailed out November 27th

Approximately two dozen responses received

Evaluation and prioritization process to be completed by end of January

Status of Evaluation of Self-Build Option

Final report and cost estimate due by mid/late January
