**NOTICE RESCHEDULING HEARING ON MOTION TO DISMISS  
(Now set for September 16, 2020, at 1:30 p.m.)**

RE: *Murrey's Disposal Co., Inc. v. Waste Mgmt. of Wash., Inc., Waste Mgmt. Disposal Services of Or., and MJ Trucking & Contracting and Murrey's Disposal Co., Inc. v. Waste Mgmt. of Wash., Inc., Waste Mgmt. Disposal Services of Or., and Daniel Anderson Trucking and Excavation, LLC*  
Dockets TG-200650 and TG-200651 (*Consolidated*)

TO ALL PARTIES:

On July 15, 2020, Murrey's Disposal Company, Inc. (Murrey's Disposal or Company), filed with the Washington Utilities and Transportation Commission (Commission) separate complaints against Waste Management of Washington, Inc. (WMW), Waste Management Disposal Services of Oregon, Inc. (WMDSO), and MJ Trucking & Contracting, Inc. (MJ Trucking) and WMW, WMDSO, and Daniel Anderson Trucking and Excavation, LLC (DAT) (collectively, Respondents), asking the Commission to order WMW, WMDSO, MJ Trucking, and DAT to cease and desist from engaging in the collection and transportation of solid waste without a certificate of authority from the Commission and to find that certain intermodal motor carrier transportation services offered by WMW or WMDSO are not preempted by 49 C.F.R. § 1090.2.

On August 4, 2020, Respondents filed with the Commission Answers to the complaints and motions to dismiss pursuant to WAC 480-07-380(1).

The Commission required the filing of any responses to Respondents' motions to dismiss by August 20, 2020.

On August 20, 2020, Murrey's Disposal filed with the Commission responses to Respondents' motions to dismiss.

On August 24, 2020, Respondents filed motions for leave to reply.

On August 27, 2020, the Commission issued Order 01 in Dockets TG-200650 and TG-200651, consolidating the dockets, denying Respondents' requests to reply, and setting a virtual hearing on the motion to dismiss for September 11, 2020 at 10:30 a.m.

On August 31, 2020, Murrey's Disposal communicated with the presiding administrative law judge and requested that the Commission reschedule the virtual hearing to a later date. The parties collaborated and agreed upon a proposal to reschedule the virtual hearing for September 16, 2020, at 1:30 p.m.

The Commission finds good cause to grant Murrey's Disposal's request, accept the Parties' joint proposal, and reschedule the virtual hearing for September 16, 2020, at 1:30 p.m. to allow adequate time for all parties to prepare for the virtual hearing.

**THE COMMISSION GIVES NOTICE That the hearing on the motion to dismiss in Dockets TG-200650 and TG-200651 (*Consolidated*) is rescheduled to Wednesday, September 16, 2020, at 1:30 p.m.**
