- On November 26, 2001, Puget Sound Energy, Inc. filed with the Commission certain tariff revisions designed to effect a general rate increase in its rates for electric service in this state. It is indicated that the total effect of such tariff revisions is an increase of approximately \$228,300,000 (16.5%) annually. On December 3, 2001, Puget Sound Energy, Inc. filed with the Commission a Petition for Interim Rate Relief requesting an increase of approximately \$170,727,000 (21.6%) to recover the difference between electric power costs embedded in current general rates and projected power costs for the period January 1, 2002 to October 31, 2002. By order of the Commission, the operation of the general and interim tariff revisions have been suspended pending hearing or hearings concerning all such changes and the justness and reasonableness thereof.
- Hearing in this matter is being held pursuant to Part IV of chapter 34.05 RCW pertaining to adjudicative proceedings, including but not limited to RCW 34.05.413, RCW 34.05.422, RCW 34.05.431, RCW 34.05.440, RCW 34.05.449, and RCW 34.05.452. The Commission has jurisdiction over this matter pursuant to Title 80 RCW, having legal authority to regulate the rates, services, and practices of electric utilities. The statutes and rules involved, in addition to those previously cited, include those within chapters 80.04 and 80.28 RCW and chapters 480-09 and 480-100 WAC. The ultimate issues include whether the proposed general and interim tariff revisions are just, fair, reasonable, and sufficient and in the public interest. The ultimate issues also include whether Puget Sound Energy, Inc.'s current rates on file and effect with the Commission are just, fair, reasonable, and sufficient. These issues include consideration of alternative rate design or structure. In accordance with the provisions of RCW 80.04.130 the burden of proof to show that the proposed general and interim tariff revisions are just and reasonable shall be upon the respondent.
- 3 NOTICE IS HEREBY GIVEN That in accordance with WAC 480-09-700(1)(a), the Commission has determined that good cause exists for this matter to be heard on shortened notice.

- 4 NOTICE IS FURTHER GIVEN That a prehearing conference in this matter will be held at 1:30 p.m., on December 20, 2001, in the Commission's Hearing Room, Second Floor, Chandler Plaza Building, 1300 S. Evergreen Park Drive S.W., Olympia, Washington.
- The purpose of the prehearing conference is to consider formulating the issues in the proceeding with respect to both the general and interim rate filings, and to determine other matters to aid in its disposition, as specified in WAC 480-09-460. Petitions to intervene should be made in writing prior to the hearing date or made orally at the hearing. The time and place for the evidentiary hearing will be set at the prehearing conference or by later written notice. Appearances will be taken.

- NOTICE IS FURTHER GIVEN THAT ANY PARTY WHO FAILS TO ATTEND OR PARTICIPATE IN THE HEARING SET BY THIS NOTICE, OR ANY OTHER STAGE OF THIS PROCEEDING, MAY BE HELD IN DEFAULT IN ACCORDANCE WITH RCW 34.05.440. THE PARTIES ARE FURTHER ADVISED THAT THE SANCTION PROVISIONS OF WAC 480-09-700(4) ARE SPECIFICALLY INVOKED.
