A letter dated October 18, 2021 states, "We're committed to delivering the consistent, affordable power...." Raising the rates appears contrary to the statement of it being "affordable". Affordable is very subjective and with most of us still pulling out of massive debt from the pandemic, increasing the rates at this time is a slap in the face and a bold face lie contained in their letter.

They also state in the letter that their prices in Washington are the lowest in the nation. If the low prices have worked in the past then they can continue to work without an increase. It would seem to me that part of their reasoning in raising prices is to be like the neighbors. That is not sufficient justification for raising prices in my opinion.

It goes on to state, "Pacific Power currently offers a variety of options to help you save energy and money." Raising rates does not allow us to save money. Also, in regards to the options they mention, none of them are available to me because I have a job and don't qualify for a reduction.

Also, "Detailed information about the regulatory filing is included with this letter." The information provided in the letter is the rate increase and when they want it to take effect. No explanation as to why the rate increase is needed and how that will keep the utility open to provide electricity to those of us end users is contained in the letter.

The electrical at my house is not in need of an upgrade nor are any of the lines that provide power to my house in need of an upgrade. This rate increase only increases the cost of the same service I am currently receiving. I will not be receiving an increase in power flow or upgrade to any physical structure that provides power to my house.

I, like many others, have experienced a significant decrease in income because of COVID. I don't have the ability to pay more for the same service and same product delivered under the same conditions.

Their letter is deceiving and manipulative, no additional information has been provided to justify from them about a rate increase, and no upgrades to any electrical system will be completed to make it so I can receive more electricity commensurate with the increase in rates.

I request you fully and completely deny their current request for a rate increase and hold them accountable to budget appropriately with the resources and income they currently have. Please deny their request.
