REGULAR MEETING – Call to Order

The regular meeting of the Board of Pilotage Commissioners was convened at 10:00am by Chair Sheri Tonn via Conference Call and Microsoft Teams.

Chair Tonn welcomed the Board's new American Shipping representative Andrew Drennen, Polar Tankers, and thanked outgoing Commissioner Phil Morrell for his many years of service to the BPC and the state of Washington. Commissioner Drennen introduced himself and shared his maritime background.

BPC Staff Report.

- > Reports of COVID in the 2901 building continue and recently impacted mailroom operations including BPC meeting material packets.
- ➤ The Governor's waivers of certain portions of the Open Public Meetings Act, which he has continuously extended since his emergency orders, will now be extended until those emergency proclamations are lifted or until the Legislature or the Governor rescinds the proclamations, whichever happens first.
- State Risk Management has rolled out a new database for evaluating and tracking agency risks. BPC committees will be assigned corresponding risks and identification of new risks as a part of their committee work. BPC Program Analyst Bettina Maki will be maintaining the database. Risks were discussed at the recent Pilot Safety Committee meeting and will be on the agenda for other BPC committees in the coming months.
- ➤ BPC Program Analyst Bettina Maki provided information and answered questions regarding the monthly data charts. This information can be found on the BPC website. Regarding the difference in revenue per assignment between the Puget Sound and Grays Harbor Pilotage Districts, Bettina will bring additional information to the next meeting.

BPC Chair Report.

- Amy Scarton, WSF Assistant Secretary, has been promoted to Deputy Secretary of WSDOT. Amy will be missed, but it will be nice to have someone who understands the BPC at the WSDOT leadership level. Her replacement is Patty Rubstello, who currently leads WSDOT's Urban Mobility and Access Team. The Board looks forward to getting to know and work with Patty.
- ➤ In mid-December, Chair Tonn and Jaimie Bever had a good meeting with Senate Transportation Committee Chair Senator Hobbs for the annual transportation agency check-in prior to the beginning of the legislative session.

Activity Reports. Mike Folkers representing the <u>Port of Grays Harbor (PGH)</u>, Lou Paulsen representing the <u>Northwest Seaport Alliance (NWSA)</u>, Mike Moore representing <u>Pacific Merchant Shipping Association (PMSA)</u>, Captain Ivan Carlson representing <u>Puget Sound Pilots (PSP)</u>, and Laird Hail representing the <u>United States Coast Guard (USCG)</u> offered current and projected statistical data as well as updates on current maritime issues and activities.

As a part of his activity report, Captain Carlson discussed COVID protocols for both pilots and trainees. He will continue the discussion on handling the potential cases and exposures with both PSP and the BPC. Regarding reporting of COVID exposures, Captain Carlson requested that an official Fit/Not Fit for Duty process not be required by the Board based on how cumbersome the reporting would be for PSP. Bettina pointed out that during the summer, PSP had reported when pilots were taking a comp day because of COVID exposure on their monthly activity report. She suggested that could be a good path forward. Linda Styrk clarified that "taking the book" is when a pilot decides to take a comp day and that the decision is not a request, it is a notification, which is driven by the individual pilot. She assured the Board that when a vessel comes in and there is exposure risk, PSP meets with Discovery Health MD and that there is a strict policy for notifications and process regarding risk exposure. Chair Tonn said that she and Captain Carlson had discussed PSP including a summary of vaccinations and other issues going on with COVID on the monthly Activity Reports. If a pilot has COVID, then the BPC would require the Fit/Unfit for Duty notification process.

OLD BUSINESS

Chair Tonn announced a Closed Session at the end of the meeting to discuss personnel matters.

M/V Levant Incident. The Board reviewed the Preliminary Investigation Report of the December 15, 2019 incident involving M/V LEVANT at the January 16, 2020 BPC meeting. At that meeting, the Board took action requiring the pilot of record to complete several actions. Jaimie Bever walked the Board through the documents provided to the Board indicating the pilot's completion. The requests included Bridge Resource Management training, Portable Piloting Unit (PPU) training, a white paper regarding effective bridge resource management and sleep inertia, and two training trips with Trainee Evaluation Committee pilots. The USCG investigation report was provided to the Board and the NTSB final report is forthcoming. The NTSB report may include industry-wide recommendations, but nothing specific to the pilot of record. There were no public comments.

Motion: Anthony/Kirtley – file M/V LEVANT investigation as an incident with damage and with pilot error and that the pilot has completed the subsequent actions required by the Board – Carried.

NEW BUSINESS

Meeting Minutes.

<u>Motion:</u> Hamilton/Jensen – approve the December 10, 2020 meeting minutes as drafted with two small changes to the TEC section recommended by the TEC Chair, John Scragg – Carried.

2021 Board Meeting Schedule. The Board previously adopted the 2021 meeting schedule. However, the adopted dates did not align with all of PSPs change days, which was the intent of moving the Board meetings during cruise season per PSP's request. Captain Carlson confirmed that the revised dates aligned with PSP's request.

Motion: Anthony/Hamilton – accept the proposed 2021 meeting dates revisions – Carried.

Committee Actions.

Trainee Evaluation Committee (TEC)

➤ Consideration of Licensure of PSPD Pilot Candidate: Severin Knutsen. On behalf of the Trainee Evaluation Committee (TEC), Commissioner Scragg stated that Captain Severin Knutsen has successfully completed all sections of his Training Program Agreement including successful Portable Piloting Unit (PPU) training and completion of his federal licensing requirements. However, while confirmation has been received that the federal sticker has been approved, the sticker itself has not yet arrived. Commissioner Scragg added that Captain Knutsen has proven to be consistent, safe, and able to pilot independently. The Board has received his TPTR Summary and all training comments.

<u>Motion</u>: Scragg/Anthony – issue Captain Severin Knutsen state pilot license number #214 for the Puget Sound Pilotage District upon receipt of his federal pilotage endorsement – Carried

- ➤ Approval of Pilot License Upgrade Program: Captain Adam Seamans. Captain Seamans is nearing completion of his second license year. Captain Seaman's upgrade program letter has been updated to reflect the new license levels.
 - <u>Motion:</u> Scragg/Anthony approve the pilot license upgrade program for Captain Seamans as proposed Carried.
- ➤ Emergency Rulemaking for WAC 363-116-078 Training Program. This emergency filing will expire soon and needs to be refiled if the Board wants to continue paying training stipends per the provisions of the rule. The committee discussed the filing and recommends the Board extending and refiling the rule.
 - <u>Motion:</u> Scragg/Anthony refile the WAC 363-116-078 Emergency Rule regarding training stipends in response to Governor Inslee's current COVID-19 emergency orders Carried.
- TEC Appointment. Captain Ryan White has retired from the Port of Grays Harbor, and consequently has left the TEC. Mike Folkers, the Grays Harbor delegate will continue as Grays Harbor representation. Captain Eric Klapperich has been elected PSP Vice-President and feels his schedule prevents him from being able to attend TEC meetings regularly. The TEC recommends that Captain Sandy Bendixen replace Captain Klapperich.
 - <u>Motion:</u> Scragg/Anthony appoint Captain Sandy Bendixen to replace Captain Eric Klapperich as a pilot representative on the TEC Carried.
- The TEC reviewed training programs for current trainees. There were no interventions to report. There are seven trainees in Puget Sound: two in the Observation Phase, four in the Training Phase, and one in the Evaluation Phase. There is one trainee in Gray's Harbor who is in the Training Phase. Three new trainees, the remainder of the 2018 exam list, have agreed to start training in the Puget Sound Pilot District on March 1, 2021. One candidate resigned from the 2018 exam list as he is training in San Francisco.
- A Train-the-Trainer virtual course has been established for the three recently licensed pilots and all the current trainees. Board members who have not attended a Train-the-Trainer are encouraged to attend either the session on Friday, January 22 or Friday, February 5, 2021. Jolene reports that approximately twenty individuals were signed up to attend both courses, including licensed pilots, trainees, candidates, and Board members.

Exam Committee

- ➤ The Committee met on January 11th, reviewed 14 applications, and determined that 12 of the 14 applicants qualified under WAC 363-116-0751 to sit for the April 5, 2021 written exam. Two of the applicants were not qualified due to their sea service.

 Motion: Scragg/Anthony approve the 12 qualified candidates to sit for the April 5, 2021 Written
- ➤ Development of the Simulation Evaluation continues at PMI with four more sessions scheduled for March 1st and 2nd and 8th and 9th. Commissioners interested in the development are encouraged to attend.

Pilot Safety Committee (PSC)

- ➤ The PSC met on January 13th to finalize draft language for WAC 363-116-081 Rest Rules. The proposed changes to this rule regarding mandatory rest periods are necessary due to the passage of House Bill 1647 during the 2019 Regular Legislative Session, which amended RCW 88.16.103 Mandatory Rest Periods for Pilots. This new rule language would codify that pilots have a mandatory rest period of at least ten hours with an opportunity for eight hours of uninterrupted sleep after the completion of an assignment. In addition, the rule defines multiple assignments within a harbor area and codifies and defines the existing practice of Puget Sound Pilots to receive an extended rest period after three consecutive night assignments. A public hearing for this rule will be held on March 18, 2021.
 - Motion: Scragg/Kirtley file the proposed CR-102 for WAC 363-116-081 Carried.
- The other topics at the meeting included COVID and vaccinations, and Risk Management as described in the Staff Report. The next PSC meeting will be scheduled for March.

BPC Staff Report.

- > Stakeholders were reminded that the close of business on the Wednesday the week before the Board meeting is the deadline for meeting materials. Staff appreciates that Puget Sound Pilots is consistent in meeting that deadline.
- ➤ Jaimie Bever attended both the Puget Sound and Grays Harbor Safety Committee recent meetings. Additionally, the BPC offered two Train-the-Trainer sessions, one on January 22 and the other on February 5. Jaimie attended the January session in full. Chair Tonn provided opening remarks at both sessions and attended the February session in full.
- ➤ Work on the 2020 BPC Annual Report is underway. With the pandemic, 2020 will be an interesting year to recap.
- ➤ BPC Program Analyst Bettina Maki provided information and answered questions regarding the monthly data charts, as well as answered questions from last meeting regarding the difference in revenue per assignment between the Puget Sound and Grays Harbor Pilotage Districts. The monthly data can be found on the BPC website in meeting materials.

BPC Chair Report.

- ➤ Chair Tonn reported that the BPC is aware of the fire aboard the *ALEUTIAN FALCON* in the Hylebos Waterway in Tacoma and is receiving updates from the Department of Ecology.
- The BPC wrote a letter to Amy Scarton, former WSF Assistant Secretary who has been promoted to Deputy Secretary of WSDOT, thanking her for partnership with the BPC while at WSF. A second letter welcoming her replacement Patty Rubstello, also was issued by the BPC. That letter prompted a meeting with Chair Tonn, Jaimie Bever, Patty Rubstello and John Vezina at WSF. Chair Tonn and Jaimie briefed Patty on the work of the BPC. In addition, Patty was invited to join the BPC/PSP Joint Diversity Committee (Amy was a committee member) and it led to an invitation for Jaimie to participate in the WSF Diversity Advisory Group. She will attend the next meeting.
- Chair Tonn and Jaimie Bever also had a good meeting with Jennifer Hennessey, Policy Advisor with the Governor's Office, and Commissioner Jensen to provide further details about the BPC, and Ecology's Spills Program.
- Congratulations to Commissioners Anthony and Drennen for a successful Senate Transportation Committee hearing and subsequent appointment confirmation.

As a part of the PSP activity report, Captain Blair Bouma reported on changes to PSP's General Guidelines for Vessels Transiting Restricted Waterways or Ports. In addition, PSP Executive Director Linda Styrk followed up from last meeting and announced that pilot trainees will have the opportunity to use Discovery Health MD in the event of a COVID exposure.

The Board received updates regarding the fire aboard the *ALEUTIAN FALCON* from the Northwest Seaport Alliance, the USCG, and from the Department of Ecology.

Committee Actions.

Trainee Evaluation Committee (TEC)

- Approval of Pilot License Upgrade Program: Captains Dave Henderson & Chris Rounds. Captains Henderson and Rounds are nearing completion of their fourth license year. Both Captains upgrade program letters have been reviewed by the TEC and are updated to reflect the new license levels.
 - <u>Motion:</u> Scragg/Farrell approve the pilot license upgrade program for Captains Henderson and Rounds as proposed Carried.
- Approval of Training Programs: Captains Larry Holland, Kevin Riddle & Matt Cassee. Captains Holland, Riddle and Cassee will start the pilot training program in the Puget Sound Pilotage District on March 1, 2021. The training programs are the standard forms. Their assigned initial ports are Tacoma for Captains Holland and Riddle and Seattle for Captain Cassee. Orientation for these new trainees is scheduled for February 25, 2021.
 - <u>Motion:</u> Scragg/Anthony approve the pilot training programs for Captains Holland, Riddle and Cassee and authorize initial ports Carried.
- The TEC reviewed training programs for all current trainees. There were no interventions to report. Three trainees attended the TEC meeting, Captains Bostick and Mann who will be transitioning from the Observation to the Training Phase, and Captain McMullen who is transitioning from the Training to Evaluation Phase. Captain McMullen was issued a letter from the Board advising that he has the option to move to Puget Sound from Grays Harbor while in the Evaluation Phase if certain conditions were met. Captain McMullen reported to the TEC that training in Grays Harbor was going well and that he was learning a lot. There are currently seven trainees in Puget Sound: two in the Observation Phase, four in the Training Phase, and one in the Evaluation Phase. There is one trainee in Gray's Harbor who is in the Training Phase.
- As reported in the Staff Report, two Train-the-Trainer virtual courses were completed by all the 2018 Exam list except for one, and one current licensed pilot. Commissioner Jensen also was able to attend. While the virtual format of the course worked well, the course will be most effective conducted in person. Chair Tonn added that she enjoyed attending the February session and getting to know the trainees.

Exam Committee

- The Committee met again on February 11 and reviewed 9 applications. The TEC determined that 8 applicants qualified under WAC 363-116-0751 to sit for the April 5, 2021 Written Exam. The 9th application was incomplete and will be reviewed at the next Exam Committee meeting. Training Program Coordinator Jolene Hamel reported that the Board has received 30 applications to date. While there does not appear to be any diversity in gender so far in the applicants, there is a Native American applicant.
 - <u>Motion:</u> Scragg/Anthony approve the 8 qualified applicants to sit for the April 5, 2021 Written Exam per the Exam Committee's recommendation Carried.

WAC 363-116-081 Rest Periods for Pilots. The changes to this rule are necessary due to the passage of House Bill 1647 during the 2019 Legislative Session, which amended RCW 88.16.103 Mandatory Rest Periods for Pilots and became effective July 28, 2019. This new rule will codify that pilots have a mandatory rest period of at least ten hours with the opportunity for eight hours of uninterrupted sleep after the completion of an assignment. In addition, this rule defines multiple assignments within a harbor area, and codifies and defines the existing practice of Puget Sound Pilots to receive a mandatory rest period after three consecutive night assignments. This rule change is the result of the efforts and collaboration of the Board's previous Fatigue Management Committee (FMC) and the current Pilot Safety Committee (PSC), which are both comprised of pilots, industry, and Board members. The Board received one oral question from the Port of Grays Harbor Executive Director Gary Nelson seeking clarification for moves within a harbor area and how harbor area was defined. Chair Tonn closed the public hearing at 10:05 a.m.

REGULAR MEETING – Call to Order

The Regular Meeting of the Board of Pilotage Commissioners was convened immediately following the Public Hearing by Chair Sheri Tonn via Conference Call and Microsoft Teams.

BPC Staff Report.

- ➤ Commissioner Krombeen will go before the Senate Transportation Committee for his reappointment hearing on March 23, 2021.
- ➤ There are two bills working their way through the 2021 Legislative Session that affect the BPC. ESSB 5395 authorizes agencies to provide state employees with office supplies, services, and

other materials necessary for employees to effectively work from home when necessary, allows agencies to reimburse employees since April 1, 2020 for additional expenditures necessarily incurred due to work from home orders due to COVID 19, requires OFM to adopt policies and procedures for the purchase or reimbursement of supplies, services, and other materials, authorizes state employees to use state internet resources outside of normal business hours during the proclaimed state of emergency for social activities that are no expense to the state, and authorizes OFM to convene a work group to study remote work and to provide recommendations regarding policies to more effectively allow state employees to work remotely. ESHB 1274 concerns cloud computing solutions regarding telecommunications and cloud consulting services.

➤ BPC Program Analyst Bettina Maki provided a revised data report regarding assignments per pilot, correcting a minor error made on the previous report provided to the Board.

BPC Chair Report.

- ➤ Chair Tonn and Jaimie Bever participated in Cal Maritime's annual Women in Maritime Leadership Conference held virtually on March 4th and 5th. Chair Tonn encouraged attendance at next year's conference, especially if it is again held virtually.
- ➤ Chair Tonn and Jaimie Bever will be meeting with House Transportation Committee Chair Representative Jake Fey next week to discuss the BPC budget, the Governor's Office of Equity, and how the BPC can be involved in the statewide equity initiative.

Activity Reports. Laird Hail representing the <u>United States Coast Guard (USCG)</u>, Mike Folkers representing the <u>Port of Grays Harbor (PGH)</u>, Mike Moore representing <u>Pacific Merchant Shipping Association (PMSA)</u>, Captain Ivan Carlson representing <u>Puget Sound Pilots (PSP)</u>, and Lou Paulsen representing the <u>Northwest Seaport Alliance (NWSA)</u>, and Mike Moore representing <u>Pacific Merchant Shipping Association (PMSA)</u> offered current and projected statistical data as well as updates on current maritime issues and activities.

Chair Tonn mentioned a recent allision of an empty barge into the docks of private properties just north of Gig Harbor, adding that there was no pilot on board the tug or involved in the incident. She asked Captain Hail to provide some additional information. He responded that because of the ongoing investigation, he was limited in what he could say. He did say that the tug operator appeared to have fallen asleep prior to the allision.

Board's decision was taken very seriously and acknowledged that the bar is very high on sea time qualifications, as well as the exam process. ESHB 1578 Update. The Department of Ecology presented an update on the Synopsis of Changing Vessel Traffic Trends at the February Board meeting with the intention that updates would continue to be provided monthly to the Board members via a slide deck, but not necessarily presented verbally at the Board meetings. For this meeting, the Board received an updated slide deck. If Board members have questions, they can direct those to either Jaimie Bever or Commissioner Jensen. There were no other updates. Chair Tonn complimented Commissioner Jensen's staff at Ecology, adding that they were a fantastic group to work with.

Maritime Blue Overview. Commissioner Eleanor Kirtley, Board of Directors Co-Vice-Chair of Washington Maritime Blue, provided a brief overview of the organization. Commissioner Kirtley provided links to the Maritime Blue website, inviting commissioners to follow along as she spoke to the mission, goals, and programs of Maritime Blue. Commissioner Kirtley suggested that newly appointed Maritime

Blue President and CEO Joshua Berger attend the next BPC meeting to discuss an open invitation to the BPC to join Washington Maritime Blue on the organizational level. A brief Q&A followed. There was positive consensus among Board members to invite Joshua Berger to the next meeting.

Committee Updates.

Trainee Evaluation Committee (TEC)

- The committee met on March 17, 2021 to review trainee reports. There were no interventions. There are currently ten trainees in the Puget Sound Pilotage District. One is in the Evaluation Phase, six are in the Training Phase three are in the Observation Phase. There is trainee in the Grays Harbor Pilotage District who is currently in the Training Phase.
- Regarding Initial Route requirements, the TEC agreed that trainees must submit their application for federal pilotage on their Initial Routes while on stipend within 8 months or off stipend within 15 months of the start of their programs, in accordance with WAC 363-116-078. But that they do not need to receive their endorsements. This decision was due to COVID 19 shutdowns that occurred at the Regional Exam Center (REC) and the difficulty the trainees have had obtaining their initial route pilotage endorsements. It is also in concert with the Emergency Rule filed by the Board on WAC 363-116-078, which allows the TEC to adjust the Training Program due to the pandemic.
- ➤ The TEC discussed the current COVID 19 restriction of one trainee per vessel and the difficulty it will pose to the three new trainees in the Observation Phase. The committee agreed that up to two trainees would be allowed on a vessel unless the vessel or pilot would not allow it. They believed this small change will help trainees move through the system more easily, with minimal health risks.
- Finally, we discussed the distribution of white papers, confirming that they should be sent to pilots and trainees as lessons learned.

BPC/PSP Joint Diversity Committee (JDC)

- JDC Co-Chair Sheri Tonn reiterated that Captain Eric vonBrandenfels has agreed to co-chair the committee on behalf of PSP. In addition, Puget Sound pilot Captain Sandy Bendixen has joined the committee.
- ➤ A meeting will be scheduled soon now that transitions are in place.
- Jaimie Bever has joined and recently attended Washington State Ferries' Diversity Advisory Group (DAG) and related Recruitment sub-committee. The group is currently working on an antiracist policy for WSF as well as a charter. She added that it was interesting listening to WSF have similar conversations as the JDC. She will share more information after the next DAG meeting. Commissioner Krombeen added that Holland America Group is embarking on a similar effort. He reiterated that they are not using the term "master" any longer. There is a complete cultural overhaul going on in the industry.
- > The Board was provided with the program for Cal Maritime's 2021 Women in Maritime Leadership Conference. Co-Chair Tonn provided an overview of a few of the presenters.

Consideration of Simulator Evaluation Process/Results and Set the Cut Score. Psychometric expert, Dr. Norman Hertz, on contract with the Board through MITAGS, and Emily Hopkins, MITAGS, gave an overview of the Simulator Evaluation process, which included a detailed description of the conjunctive scoring model and extended Angoff methodology.

<u>Motion:</u> Farrell/Drennen – set the Simulator Evaluation cut score at 20 pursuant to WAC 363-116-077(4) as determined by the Subject Matter Experts and recommended by Dr. Hertz – Carried.

Based on the cut score of 20, 10 applicants were deemed successful and will qualify as minimally competent to enter the Pilot Training Program. There was a tie in 2 of the lower positions. Chair Tonn announced that the Board would use the random method of a coin toss to determine the tie-breaker. The candidate in the higher position on the list was assigned heads and the lower tails. Executive Director Jaimie Bever called tails, and the lower candidate was the winner. The lower candidate earned the higher ranking on the published list.

This scoring information will be posted on the BPC website and sent via email to all applicants by 4:00 p.m. this afternoon. All applicants will continue to be referenced by an ID number only until the entire exam and review process is complete. This list is not final until an opportunity for review has been given to those requesting a review of their Simulator Evaluation results and the review process has been completed by the BPC.

Chair Tonn thanked Dr. Hertz for his involvement, MITAGS for doing an excellent job on the technical side, the many pilots who assisted in the development, and everyone else involved.

BPC Staff Report.

- > The current Spring 2021 issue of the BPC Pilotage Quarterly had been distributed and posted on the BPC website.
- Over the next several months, Board meetings will not occur on the third Thursday of the month to better accommodate the pilot's schedules. Please refer to the list of the next 5 meeting dates/times at the end of today's meeting agenda.
- ➤ The BPC has secured Public Officials and Employment Practices liability insurance as of April 6, 2021. Jaimie Bever acknowledged and thanked Tosca Pinder of ABD, whom Jaimie met at a Cal Maritime's Annual Women in Maritime Leadership Conference a couple years ago. Tosca was paramount in successfully explaining our agency and insurance needs to underwriters.
- The Office of the Washington State Auditor will be conducting a routine accountability audit of the BPC for fiscal years 2016-2020. BPC Program Analyst Bettina Maki will be the liaison with the Auditor's office. The final report will be provided to the BPC by July 31, 2021.

BPC Staff Report.

- The Office of the Washington State Auditor will be conducting a routine accountability audit of the BPC for fiscal years 2016-2020. After preliminary consultations with BPC Chair and Staff, they have decided to use trainee stipend payments as the benchmark for the audit analysis and have requested an audit sample. Jolene Hamel, Training Program Coordinator, has gathered all of the documentation requested. The final report will be provided to the BPC by July 31, 2021.
- ➤ Washington State Ferries is celebrating their 70th anniversary this year and will be having some public celebrations.
- ➤ Preparations have begun at the 2901 building to prepare WSF offices for a permanent teleworking/in-person hybrid model moving forward. Drop-in workstations with easy plug and play setups for laptop work and small group meeting spaces will be available. Commissioner Jensen inquired about the ability for other state agencies accessing these spaces while in Seattle, which BPC staff will investigate further. Currently the Open Public Meetings Act is still restricting inperson meetings of more than five individuals.
- ➤ Jaimie Bever is working on a BPC office reopening plan, which she will bring before the Board at the June meeting.

BPC Staff Report.

- The Office of the Washington State Auditor has concluded their routine accountability audit of the BPC for fiscal years 2016-2020. The Board received the Auditor's exit letter for review. There were no findings or exit items to report. BPC Executive Director Jaimie Bever thanked Training Program Coordinator Jolene Hamel for great record keeping and organization, and Program Analyst Bettina Maki, who as audit liaison worked diligently to provide clarity and transparency in BPC processes. The next audit will be conducted in 2025.
- ➤ The Board reviewed the proposed BPC office reopening plan, which is scheduled to go into effect on August 16 with a hybrid schedule of some in-office and some telework. The plan will be evaluated in 3 months' time to make sure all business needs are being met. A question was raised about in-person meeting plans and mask wearing mandates in state office buildings both of which we are pending direction from the Governor's Office. The BPC anticipates being able to offer in-person meetings with a virtual component in the future.
- ➤ Jaimie Bever attended both the Puget Sound and Grays Harbor Safety Committee meetings since the last Board meeting along with a stirring and inspiring Juneteenth virtual meeting hosted by WSDOT, which Bettina Maki also attended. Commissioner Kirtley inquired if the Juneteenth Celebration was recorded with the ability to share with the Board. Staff will look into this request.
- ➤ The 2020 Annual Report draft will be presented in July for Board and stakeholder comment. The final draft will be presented for Board adoption at the August meeting and submitted to the Legislature shortly thereafter.
- ➤ Bettina Maki presented and answered questions on the 2020 rest rule exemptions chart provided to the Board, which will become a Pilot Safety Committee report in future meetings.

BPC Chair Report.

- ➤ The Department of Ecology has appointed a replacement for Commissioner Dale Jensen, who announced his retirement for August 2021. Nhi Irwin, Statewide Resources Section Manager, will begin her appointment on August 1. She has been with Ecology for 14 years and is very connected in the spills/maritime industry both within Puget Sound and British Columbia.
- > A replacement for the Foreign Shipping seat recently vacated by Rik Krombeen has not yet been appointed by the Governor's Office.

- ➤ Chair Tonn and Jaimie Bever met with the Port of Grays Harbor to discuss a new trainee and possibly establishing a committee dedicated to Grays Harbor pilotage, similar to the Board's past Grays Harbor Advisory Committee. More information about that effort is forthcoming.
- Chair Tonn reported that she sent a comment letter of support for MITAGS on behalf of the BPC regarding the USCG's proposed expansion project.

BPC Staff Report.

BPC staff will set up a time with each Board member to review and record vaccine verification.
- ➤ BPC staff provided a visual of the 2021-2023 budget allotments. Staff is also working on a supplemental budget request for FY 2022, which is due September 13, 2021. A brief Q&A between staff and the Board followed.
- Department of Ecology has announced that Carlos Clements will be replacing Dale Jensen as the Spills Program Manager and will be starting at the end of August. The BPC welcomes Carlos and hopes he will attend a meeting soon to introduce himself and share his background and experience with the Board.
- ➤ BPC Training Program Coordinator Jolene Hamel has received a state-issued cell phone for all BPC business.
- ➤ Former Commissioner Sara Thompson will be out on leave from September 2021 through January 2022. Brian Kirk will be filling in for her on both the OTSC and the TEC. Board member Nhi Irwin will step in for Sara on the JDC.
- > The Board received Q2 data for the Port of Grays Harbor.

BPC Chair Report.

- Chair Tonn welcomed new Board member Nhi Irwin, Department of Ecology, who was appointed to fill the Ecology seat vacated by Dale Jensen. Commissioner Irwin shared information regarding her background, highlighting her fifteen years in Ecology's Spill Program, and her excitement to be on the Board.
- > This month is very likely Commissioner John Scragg's last Board meeting. He spent a little time reflecting on work with the BPC. He will be staying on both the TEC and the PSC for the foreseeable future. Commissioner Scragg expressed his appreciation for being on the Board. He

gave a special thanks to Chair Tonn for her leadership and to BPC staff for their support and professionalism. Chair Tonn thanked him for his years of service to the Board and the state of Washington. Commissioner Farrell added his appreciation for Commissioner Scragg's patience, knowledge, and willingness to share information, as well as his level-headed approach. Captain Sandy Bendixen will be replacing Commissioner Scragg in one of the two pilot representative seats in September.

➤ Chair Tonn thanked the U.S. Coast Guard for the recent meeting to continue discussions regarding first class federal pilotage in Puget Sound.

Activity Reports. Mike Moore representing <u>Pacific Merchant Shipping Association (PMSA)</u>, Lou Paulsen representing the <u>Northwest Seaport Alliance (NWSA)</u>, Captain Ivan Carlson representing <u>Puget Sound Pilots (PSP)</u>, Laird Hail representing the <u>United States Coast Guard (USCG)</u>, and Mike Folkers representing the <u>Port of Grays Harbor (PGH)</u>, offered current and projected statistical data as well as updates on current maritime issues and activities.

OLD BUSINESS

Vessel Exemption Appeal - M/Y WOFANU. The Board reviewed an appeal from the captain of Motor Yacht WOFANU regarding the vessel exemption previously granted by the Board with the condition of a pilot orientation cruise. Chair Tonn asked if there was a motion to reconsider the exemption condition.

<u>Motion:</u> Farrell/no second – Reconsider the pilotage exemption condition of a pilot orientation cruise. Motion fails.

Committee Actions.

Trainee Evaluation Committee (TEC)

- ➤ The TEC met yesterday and reviewed all the training programs and comments. There are currently 10 trainees in Puget Sound, and none in Grays Harbor. One trainee is close to licensure. The USCG stepped in to give a waiver on a final Spieden Channel trip that is currently closed to trainees due to COVID. Hopefully that trainee will be licensed in September. The other 9 trainees are progressing.
- Currently, trainees are required to get 12 trips/month under COVID-19 Emergency Rule. The TEC discussed trips per month required for stipend with the current conditions of 10 trainees, along with industry changes and new rest rules. This will be a continued TEC agenda topic with more information coming to the Board in either September or October.
- ➤ One trainee was in quarantine for an exposure to COVID-19 and the TEC has waived his 12-trip requirement for the month of August.
- There has been some confusion on Hard-to-Get trips and the minimum/maximum trainees on board. The TEC will be sending out a letter to mitigate the confusion on this and rest rules.
- A working group consisting of 6 pilots has been pulled together to work on revamping the Conning Quiz process for the new trainees.
- Captain Bendixen gave an update on the first-class pilot federal requirement issues. She reported that she is hopeful that the work group, which has been on hiatus, will resume soon.

- > The BPC Pilotage Quarterly newsletter Fall Edition has been distributed and posted to the BPC website
- ➤ At the end of September, Jaimie Bever attended a meeting exploring a possible anchorage subcommittee of the Puget Sound Harbor Safety Committee (PSHSC). It was confirmed at the following PSHSC that the subcommittee would be formed and meet on an ad hoc basis.
- ➤ Jaimie attended the WISTA PNW Tugboats 101 Lunch n' Learn. She thanked Commissioner Kirtley for the invite and reported that it was very educational and time well-spent.
- ➤ Bettina Maki provided and commented on 3rd Quarter vessel traffic reports for both Puget Sound and Grays Harbor.

BPC Chair Report.

➤ Chair Tonn reminded the Board about Women Offshore's annual conference coming up on November 5 and 12.

Activity Reports. Mike Moore representing Pacific Merchant Shipping Association (PMSA), Captain Ivan Carlson representing Puget Sound Pilots (PSP), Lou Paulsen representing the Northwest Seaport Alliance (NWSA), Laird Hail representing the United States Coast Guard (USCG), and Mike Folkers representing the Port of Grays Harbor (PGH), offered current and projected statistical data as well as updates on current maritime issues and activities.

Mike Folkers reported that the Port's grain ship loader at Terminal 2 has been down since September 1, 2021. He was unable to provide details as an investigation is underway. However, he did report that the Port's dry bulk customer ADP has procured two portable loaders called teleport stackers, which were delivered this week for temporary loading. Installation is underway and the vessel FEDERAL EMBARI is expected to arrive on November 4 and load 5500 metric tons of soybean meal headed for Vietnam. The Port anticipates the teleport stacker will be very beneficial to continued Port operations. The Port is working on replacement of the permanent loader in the meantime.

NEW BUSINESS

Meeting Minutes.

<u>Motion:</u> Hamilton/Kirtley – approve the September 28, 2021, Meeting Minutes with a minor grammatical change – Carried.

Committee Actions.

Trainee Evaluation Committee (TEC)

- > The BPC, PSP, and USCG have resumed communication regarding federal pilotage in Puget Sound (PS). The focus is to complete the new federal pilotage package and promulgation letter regarding the existing packet soon.
- ➤ The TEC met yesterday and reviewed all the training programs and comments. One trainee transitioned from the Training Phase to the Evaluation Phase. There are nine trainees in the PS program and zero in Grays Harbor (GH). Four trainees are in the Evaluation Phase, four are in the Training Phase, and one in the Observation Phase.
- > One trainee is on target for licensure next month.
- One of the candidates from the 2021 Exam Waiting List has received an offer for the GH training program. The candidate has visited GH and met with the Port and Captain D'Angelo. The BPC is awaiting his formal response.
- ➤ The TEC has reviewed the current PS training program agreement and requirements. The Board will receive updated versions for consideration and approval at the November 18 meeting. Additionally, the TEC will provide considerations for changes to WAC 078.
- There is a small workgroup looking at the conning quizzes and local knowledge exams to make sure the product is the best the BPC can provide and helps the trainees be successful in the training program.
- ➤ Regarding COVID-19, the trainees continue to fill out the BPC's trainee health declaration daily and follow proper recordkeeping. The number of trainees on board vessels continues to be limited as a precaution. Crowley is now allowing one trainee onboard tankers, which have a larger wheelhouse than the ATBs. Chair Tonn expressed thanks to Mark Homeyer for his efforts in getting the trainees back on board.

Vessel Exemption Committee (VEC)

- The first meeting of the VEC was last week. Commissioner Anthony, who is also the committee chair, shared that it was a productive meeting and good starting point in identifying areas of committee focus. A list of goals and possible recommendations have been compiled and will provide focus for the committee going forward.
- Monique Webber, Pacific Yacht Management, and Peter Schrappen, Northwest Marine Trade Association, recommended Captain Charlie Johnson for the Large Recreational Vessel (130-200 FT) Captain position on the committee. Captain Johnson has years of experience operating yachts in the Puget Sound area.

- The VEC will bring forward potential candidates for the last position on the committee, the Small Recreational Boating Representative, at a future meeting.
- The next meeting is scheduled for November 10.

Oil Transportation Safety Committee (OTSC)

Jaimie Bever is a member of the Washington State Ferries' Diversity Advisory Group (DAG) and the DAG's Workforce Development Subcommittee and has been attending meetings regularly.

Pilot Safety Committee (PSC)

- Commissioner Drennen, PSC Co-Chair, reported that the PSC met yesterday. The agenda included updates from PSP regarding COVID-19, a review of rest rule exceptions, an update on the pilot ladder safety report form being developed by PSP and proposed pilot ladder safety bulletin for the Board to consider at the November 18 meeting.
- Most of the meeting was focused on extended transit time for bulkers out of Tacoma, which has been a topic at several previous PSC meetings. The committee looked at 2019-2020 data, which showed that nearly all bulkers departing Tacoma had a 12-to-17-hour assignment time, which in most cases exceeds fatigue management recommendations. The assignment time includes the pilot's preparation and transportation to the vessel and the vessel's transit time from the berth or anchorage out to the pilot station. Approximately two thirds of these jobs were night jobs. The committee reviewed data, discussed scenarios with agents and operators, and discussed PSP's proposed change to their operating rules to turn the night jobs into two-pilot jobs with the pilot change-out occurring in Seattle. PSP will be sending a letter to industry with a notification of the change. Chair Tonn added that the PSC will review the results of this change over the next six months. A short Q&A followed. Chair Tonn reiterated that this change was not something the Board will approve or disapprove. It is a PSP operational change.

Before moving into the meeting agenda, Chair Tonn welcomed Captain Sandy Bendixen to the Board as a pilot representative for the Puget Sound Pilotage District. She thanked Captain Bendixen's predecessor, Captain John Scragg, for his many years of service to the Board and the State.

BPC Staff Report.

- Executive Director Jaimie Bever worked with DES and OFM to submit the BPC's 2022 Supplemental Budget.
- Program Analyst Bettina Maki, who maintains the state's Enterprise Risk Management (ERM) risk register database for the BPC, has submitted updates required by September 1, 2021. The updates were the results of brainstorming and collaboration from the BPC's committees. Going forward, the committees will discuss ERM on a quarterly basis.
- > Bettina will provide the Board with 3rd quarter data at the next meeting.

BPC Chair Report.

- Women Offshore' annual conference will be held remotely on November 5 and November 12. The BPC is a sponsor of this year's conference. Board members are encouraged to attend.
- Chair Tonn and Jaimie Bever met with Tom Griffitts, Executive Director of the Oregon Board of Maritime Pilots, on September 14. They had an excellent meeting on cross-border and other piloting issues.

COVID-19 Updates. Jaimie Bever has received the vaccine status for all BPC staff and Board members and has relayed that information accordingly to various state agencies, as required. Jaimie also had a meeting with the Deputy Director of the Pacific Pilotage Authority to learn about how Canada has been handling exposures. A short Q&A with Board members followed. In response to continued COVID-19 concerns, the BPC issued two letters with the input of Dr. Ann Jarris, of Discovery Health MD. One letter was to all shippers, and the other was specific to cruise ships. Chair Tonn thanked PSP President Ivan Carlson and PMSA Vice President Mike Moore for their help in distributing the notices, and Dr. Jarris for her assistance in preparing the notices.

Due to ongoing COVID-19 concerns, Crowley has restricted pilot trainees from accessing all vessels from Crowley Petroleum Assets. The BPC and TEC are engaged in ongoing discussions with Crowley to help minimize the impact of this restriction.

BPC Staff Report.

- ➤ BPC Executive Director Jaimie Bever attended the Pacific States/British Columbia Oil Spill Task Force Annual Meeting yesterday. The presenters included Carlos Clements, who replaced Dale Jensen as the Spills Program Manager for the Department of Ecology, who gave an update on Ecology's jurisdictional work and Commissioner Nhi Irwin, who spoke on the impacts of climate change on Ecology's work.
- ➤ The annual Joint Puget Sound Harbor Safety Committee (PSHSC) and PACMAR meeting was scheduled for December 7, however due to flooding emergencies in Canada the meeting has been postponed. The PSHSC will be meeting December 7 for a regular meeting.
- ➤ BPC Program Analyst Bettina Maki is working on creating at-a-glance dashboards for various agency programs as well as a flow chart for ESHB 1578 deliverables and considerations. Those will be coming soon.
- ➤ Jaimie reported that Bettina celebrated her 2nd anniversary with the BPC on November 1. Bettina has spent the bulk of her time with the BPC in a virtual work environment. BPC staff and Commissioners expressed their appreciation of how she has been able to learn and thrive during the past two years. Chair Tonn thanked Bettina for making data so much more accessible.

BPC Chair Report.

Chair Tonn reported on the Women Offshore's Fourth Annual Conference, which occurred on November 5 and 12. Between BPC and PSP, there were six Washington pilotage representatives. Washington pilotage had the most attendees of all the pilotage districts at the conference. Jaimie Bever acknowledged Captain Bendixen and Captain Scott Coleman for their tremendous effort on this critical project.
- > The TEC met yesterday and reviewed all the training programs and comments. Two trainees transitioned from the Training Phase to the Evaluation Phase. One trainee transitioned from the Observation Phase to the Training Phase. With the licensure of Captain Moore, there are now eight trainees in the PS program and zero in Grays Harbor (GH). Five trainees are in the Evaluation Phase, three are in the Training Phase, and none in the Observation Phase.
- ➤ One of the candidates from the 2021 Exam Waiting List has received an offer for the GH training program, and has been granted an extension until January 4, 2022, primarily due to the limited traffic in Grays Harbor while Terminal 2 is under repairs. The candidate has visited GH and met with the Port and Captain D'Angelo.
- ➤ Approval to Issue Invitations for Puget Sound. Captain Bendixen stated the TEC reviewed progress of the current pilot trainees and projected pilot retirements over the next couple of years in the Puget Sound Pilotage District. The TEC recommends inviting the next two candidates to begin training on February 1, 2022.

He also introduced Lori Crews, a highly experienced vessel inspector with Ecology, who led the effort to prepare the report. He praised

Lori's meticulous and manual data collection, and analysis using Ecology's Advanced Notice of Transfers (ANT) system and AIS to compile the information found in the report. Lori then presented the report to the Board. The slides from the presentation can be found on the BPC website at www.pilotage.wa.gov. A Q&A session followed the presentation. The deadline for Board member comments is by end of business tomorrow, November 19. The Board will review and approve the final report at the December 9 meeting and submit to the Legislature before December 31.

BPC Staff Report.

- ➤ BPC Executive Director Jaimie Bever highlighted the feature regarding women in Washington's maritime industry in the 5 December 2021 edition of The Seattle Times.
- > Two of three BPC staff have received COVID-19 vaccine boosters. Staff will be 100% boosted by the end of the year.

BPC Chair Report.

- Chair Tonn mentioned a trip to Grays Harbor since the last Board meeting, which will be reported on in the TEC section of the agenda.
- She wished everyone a happy holiday season.

Activity Reports. Lou Paulsen representing the Northwest Seaport Alliance (NWSA), Jordan Royer representing Pacific Merchant Shipping Association (PMSA), Captain Ivan Carlson representing Puget Sound Pilots (PSP), Laird Hail representing the United States Coast Guard (USCG), and Mike Folkers representing the Port of Grays Harbor (PGH) offered current and projected statistical data as well as updates on current maritime issues and activities.

NEW BUSINESS

Meeting Minutes.

Motion: Hamilton/Kirtley – approve the November 18, 2021, Meeting Minutes – Carried.

Committee Actions.

Trainee Evaluation Committee (TEC)

- ➤ Pilot License Upgrade Programs: Captains Miller and Velarde. Captain Miller and Captain Velarde are nearing completion of their second license years.
 - <u>Motion</u>: Bendixen/Anthony approve the pilot license upgrade programs for Captains Miller and Velarde as recommended by the TEC Carried
- **PPU Training: Captain Stewart.** Captain Bendixen reported that Captain Stewart is nearing the end of his training program and is ready to attend PPU training.
 - Motion: Bendixen/Anthony approve PPU training for Captain Stewart and provide a one-time stipend increase up to \$2,400 for the cost of the course Carried.
- ➤ The TEC met yesterday and reviewed all the training programs and comments. There are eight trainees in the PS program and none in Grays Harbor (GH). Even with the emergency rule in place regarding COVID-19, trainees are progressing through the training program and have been able to meet the minimum training requirements, with the majority exceeding those requirements. In PS, two candidates invited to train have accepted with a start date of 1 February 2022. One

- candidate invited to train in GH has until 4 January 2022 to make his decision. Four trainees are in the Evaluation Phase, four are in the Training Phase, and none in the Observation Phase.
- ➤ The Port of Grays Harbor hosted an in-person meeting on 30 November 2021. In attendance from the BPC were Chair Tonn, Commissioner Bendixen, Commissioner Anthony, and Executive Director Bever. Gary Nelson, Mike Folkers, and Leonard Barnes attended on behalf of the Port. The purpose of the meeting was to discuss steps forward in the GH training program. Since the Port is Board-authorized for three pilots, it was agreed to invite a second trainee into the program with a staggered start date to meet the unique training environment of GH. The TEC is currently awaiting a decision from both candidates. In the meantime, the TEC is working on the GH training program, which will be presented to the Board at the 20 January 2022 meeting for review and approval.
- ➤ Regarding COVID-19, trainees continue to fill out the BPC pilot declaration of health form, and the number of trainees onboard is still limited to two per vessel.
- Recently, PSP President Captain Ivan Carlson renegotiated a long-time standing observation opportunity with the BC Coast Pilots for trainees in the waters of Haro Strait and Boundary Pass, which has been suspended since the start of COVID. The trainees are actively taking advantage of this opportunity, which helps expedite requirements for federal pilotage.
- President Carlson and PSP Executive Director Charlie Costanzo held discussions with both Crowley and Foss regarding tug observation opportunities for the trainees. Foss has offered to continue assisting with the training program by allowing trainees to observe on their ship-assist vessels while following COVID protocols. Crowley has suspended their participation on both shipassist vessels and ATBs.
- ➤ Commissioner Farrell acknowledged Commissioner Bendixen for her exceptional work as and transition to Chair of the TEC.

ESHB 1578 Synopsis of Changing Vessel Traffic Trends. ESHB 1578 directs the Board of Pilotage Commissioners (BPC) to develop rules for tug escorts in Puget Sound for oil-laden vessels by December 31, 2025. Specifically, section 3(1)(d)(2) requires the BPC to submit to the Legislature by December 31, 2021, a Synopsis of Changing Vessel Traffic Trends to assess the effects on vessel traffic of the September 1, 2020, tug escort requirement on laden oil tankers between 5,000 and 40,000 deadweight tons, as well as articulated tug barges (ATBs) and towed waterborne vessels or barges greater than 5,000 deadweight tons in Rosario Strait and connected waterways east. The Board received the final report and a summary of the changes, put together by Lori Crews, Ecology, from the draft previously reviewed. Brian Kirk, Ecology, pointed out changes to the Executive Summary to clarify the main points Ecology was trying to convey. Commissioner Kirtley shared appreciation to Ecology for the heavy lift of putting together the report and incorporating BPC and public comments. BPC staff will submit the report to the Legislature by 31 December 2021.

<u>Motion:</u> Kirtley/Drennen – approve the final Synopsis of Changing Vessel Traffic Trends as presented by the Department of Ecology – Carried with one abstention from Commissioner Irwin.

ESHB 1578 Tug Escort Analysis Scope of Work. The Board received and reviewed the final Tug Analysis Scope of Work. Upon Board inquiry, Alex Hess, Ecology, reported that the summary of the tug escort study commissioned by the Western States Petroleum Association (WSPA), conducted at MITAGS-West, and prepared by Jeff Slesinger, Delphi Maritime, could be included as reference material for the risk model and considered during the rulemaking process. However, the full report is proprietary and has not been shared by WSPA.

<u>Motion:</u> Farrell/Anthony – approve the final scope of work as proposed by Ecology – Carried with one abstention from Commissioner Irwin.

Executive Director Bever provided information, both written and visual, to the Board regarding bill-specified BPC considerations for rulemaking and asked the Board for input. She also reported that she will be meeting with Ecology in January to discuss each agency's rulemaking process to prepare for rulemaking collaboration. Chair Tonn and Executive Director Bever continue to meet with Ecology on a regular basis.
