**NOTICE OF OPPORTUNITY TO SUBMIT WRITTEN COMMENTS

TO INTERESTED PERSONS:

This letter is to inform you of the progress made toward the Commission's rulemaking to consider establishing regulations to govern the interconnection of consumer-owned generation facilities to electric utility delivery systems. This letter also provides notice of an opportunity to file written comments on the proposed rules and to participate in the formal rule adoption hearing.

On January 18, 2006, the Commission filed a Notice of Proposed Rulemaking (CR-102) in this docket with the Code Reviser addressing interconnection with electric generators with a generating capacity of not more than 25 kilowatts. This action begins the final part of the rulemaking process, which includes a written comment period, a public adoption hearing, and a decision by the Commission. The Commission will consider rules addressing interconnection of consumer-owned generating facilities with a capacity greater than 25 kilowatts in another phase of this rulemaking.

NOTICE is hereby given of the opportunity to submit written comments on the proposed rules to the Commission by filing with the Commission Secretary either by electronic transmission as described below, or by physical delivery to 1300 S. Evergreen Park Drive S.W., P.O. Box 47250, Olympia, Washington, 98504-7250, no later than 5:00 p.m., Wednesday, February 8, 2006. The proposed rules, as filed with the Code Reviser, are available for inspection on the Commission's web site at www.wutc.wa.gov/051106. The Commission will send you a paper copy of the proposed rules or will send the proposal via electronic mail, if you ask.

Electronic copies: The Commission requests that comments be provided in electronic format to enhance public access, for ease of providing comments, to reduce the need for paper copies, and to facilitate quotations from the comments. Comments may be submitted by electronic mail to the Commission's Records Center at records@wutc.wa.gov. Please include:

- The docket number of this proceeding (UE-051106)
- The commenting party's name
- The title and date of the comment or comments

An alternative method for submitting comments may be by mailing/delivering an electronic copy on a 3 ½ inch, IBM-formatted, high density disk, in .pdf Adobe Acrobat format or in Word 97 or later. Include all of the information requested above. The Commission will post on the Commission's web site all comments that are provided in electronic format. The web site is located at <http://www.wutc.wa.gov/051106>. If you are unable to file your comments electronically or to submit them on a disk, the Commission will always accept a paper document.

NOTICE is also hereby given of the opportunity to attend the public hearing and make oral comments about the proposal for the adoption of the proposed rules at 2:30 p.m., Wednesday, February 22, 2006. This public hearing will be held in the Commission's Hearing Room, Second Floor, Chandler Plaza, 1300 S. Evergreen Park Drive, S.W., Olympia, Washington.
