## **PASSENGER RULES**

---

**Adult Fares:** Adult fares apply to passengers who have reached or passed their 13th birthday.

**Animals:** Charge for pets is \$20 minimum or full person regular fare and; they need to be in an airport approved carrier. Exception: Service animals accompanying impaired passengers will be carried free of charge. Service animals will not be permitted to occupy a seat, but must lie or stand at the feet of the passenger.

**Baggage:** The first full baggage and carry-on are free of charge. Each additional is \$4 charge. Golf clubs, bicycles, skis, trunks may not exceed an extra full fare of charge at our discretion. The customer will be told in advance; otherwise the charge will be free.

**Baggage Liability:** As provided by Washington State law (RCW 81.29.050 and WAC 480-30-476), unless a higher value is declared prior to transportation and paying an additional amount agreed to in writing by SeaTac Airport 24 the following minimum property liability will apply:

Per Adult Fare: \$100.00  
Per Childs Fare \$50.00

The maximum value per bag or item checked will be \$1,000.00 and the passengers declared amount may not exceed the actual value of the baggage and its contents.

**Holidays observed:** Seatac Airport 24 services 24 hours a day, 365 days a year.

## PASSENGER RULES

---

**Lost and Found:** SeaTac Airport 24 is not responsible for personal articles lost or left on vehicles. SeaTac Airport 24 will attempt to secure any such items at our office for up to thirty days but does not guarantee any protection or rightful return. Any items not claimed by rightful owner for a period exceeding thirty days shall be properly discarded or given to local charities.

**Objectionable passengers:** SeaTac Airport 24 reserves the right to refuse to transport persons under the influence of drugs or alcohol, or who are incapable of taking care of themselves, or whose conduct or behavior may be objectionable to other passengers. The carrier also reserves the right to refuse carriage of any materials that the carrier considers unsafe and not in the best interest of the passengers.

**Refunds:** Unused tickets will be redeemed at the purchase price and unused portions of round-trip or commutation tickets will be redeemed by charging the regular fare or fares for the portion used, and refunding the balance of the purchase price.

A customer who has made a reservation but fails to cancel, reschedule, or appear at the designated pick-up point by the scheduled departure time is not eligible for a refund unless the failure was caused by an airline delay or cancellation.

**Schedule maintenance:** Carrier will not be liable for delays caused by accidents, breakdowns, road conditions or construction, ferry closures or delays, storms, traffic or other conditions beyond the control of the carrier and does not guarantee arrival at or departure from, any point at any specific time. The carrier endeavors to maintain the time schedules, but does not guarantee to be able to do so at all times.

**Senior/Military Fares:** Senior and military fares apply to passengers who have: a) reached or passed their sixtieth birthday, or b) are currently on active duty or retired from a career in the United States armed forces, or c) are dependents of military personnel and can show military identification.
