Hello Judge Howard,

On October 22, Staff sent a data request to Shuttle Express. According to the Prehearing Conference Order, discovery will be conducted under WAC 480-07-400 – 425. Under WAC 480-07-405(7), a party has ten business days to respond to a data request. Therefore, Shuttle Express's response would be due CoB 11/5, the day after the 11/4 deadline for filing exhibits and exhibit lists. Given that Shuttle Express has until 11/5 to respond to Staff's data request, Staff requests a limited modification to or exemption from the deadline for filing an exhibit list and exhibits in order to allow Staff to file an updated exhibit list and exhibits on 11/6 incorporating the Company's response to Staff's data request.

Staff has reached out to the Company and Public Counsel and both have stated that they do not object to Staff's request.
