Re: UG-250717 - Annual Purchased Gas Cost, Deferred Gas Cost Amortization Adjustments and Combined Effects – Replacement Pages – DO NOT REDOCKET

Dear Mr. Killip:

On September 15, 2025, Northwest Natural Gas Company, dba NW Natural (NW Natural or Company), filed a tariff revision in the above-mentioned docket with an effective date of November 1, 2025, seeking to revise several tariff sheets, including the annual purchased gas cost and deferred gas cost amortization adjustments. On October 7, 2025, NW Natural updated its usage-per-customer effects on the proposed changes, filed a replacement page 3 to Exhibit A and a replacement page 1 to Exhibit B.

The purpose of this filing is to withdraw the following general rate schedule tariff sheets filed on September 15, 2025: 101.1, 102.1, 103.3, 127.1, 141.9, 141.10, 142.10, 142.10.1, 142.11, 142.12, and 143.6. These tariff sheets are replaced with the enclosed tariff sheets to reflect the incremental change to current billing rates as a supplement to the applicable general rate schedules that are temporarily suspended due to the Company's current general rate case. The new proposed tariff sheets, as listed below, are stated to become effective with service on and after November 1, 2025.

Due to the various replacement pages filed after the initial September 15, 2025 filing, NW Natural is also providing an update to the Combined Effects section of the September 15 cover letter and a full replacement Exhibit B for transparency.

1. Combined Effects

The combined effect of the rate changes proposed to become effective November 1, 2025, is a decrease to the average monthly bills in the primary rate schedules as follows: Residential Schedule 2 bills will decrease by 5.8% and commercial Schedule 3 bills will decrease 6.4%. The combined result of all components of the rate changes would be a decrease in the Company's revenues from its Washington operations of \$6,783,829, or 6.17%.
