## Advertising and Outreach

### **Universal Service Advertising**

T-Mobile advertised its universal service offerings throughout the calendar year 2011 via media of general distribution, including the use of media such as radio, television, billboards, print, internet, and targeted mailings, among other things. T-Mobile also maintains various retail stores and authorized dealer locations throughout its ETC designated service area through which it advertises its service offerings.

  - Tacoma Weekly
  - Yakima Shop & Serve
- Mailed more than 70 poster quality notices to offices where consumers likely to qualify for Lifeline would seek service, including social security and employment offices

at," said Chief of Police Rick Johnson.

Also on the agenda for the Monday night meeting were several agreement extensions and amendments to be passed. Included in that was a cabaret license application for Hot Rods Bar and Grill, which was approved.

The city has also received written approval for the second phase of the Energy Improvement Project, which includes improved lighting in the Public Works shop building; and installation of an energy efficient HVAC system in the Public Works shop building, the Waste Water Treatment Plant, and at the Fire Station.

Also approved by the council was a continuation of Prosecuting Attorney services with Eugene Hanson for \$3,500 per month.

The next issue that the council discussed was the amendment to the current agreement with Klickitat

County for jail services. The agreement will change, but for now the current agreement is extended through March 2012. Since the Klickitat County Sheriff's Office is facing a major budget cut next year, Johnson suspects an increase in costs will occur when they go back for negotiations on the jail services contract.

A new agreement with the Greater Goldendale Chamber of Commerce (Chamber) and the City was put into place Monday night as well. Next year's funding to the chamber from the city will amount of \$35,000. These funds help with operating costs of the visitor information center, the management of events and festivals, and planning for those events.

Lastly, the council approved the second reading of the 2012 Budget, which has not had significant changes in the last few months.

## Police search for General Store burglar

Goldendale Police are looking for help from the public in the identification of a man who burglarized the General Store around 10:41 p.m. on Dec. 15. Officers who were patrolling down town arrived within seconds of a call forwarded by an alarm company to 911 but the suspect had already fled the store. The front door was found open and bags of candy were on the floor. Store cameras show a male

about 5-10 to 6-feet tall, weighing an estimated 185 to 225 pounds, browsing around the store. He is believed to have dirty blonde or brown hair grown half way down his neck. Since cash is not left in the store, none was stolen and an inventory of merchandise had not been completed by press time. Anyone with information is asked to contact the police at 773-3780.

## Driver injured when semi leaves roadway

A semi-truck and trailer were totaled after running off Highway 14, two miles west of Roosevelt, last week. their portion of the payment for their health benefits.

Another cut that was on the table during the special session that started Nov. 28 was a restructuring of the Local Effort Assistance (LEA). This would give less money to districts with higher property taxes and more money to districts with lower property taxes.

Now that Klickitat County's valuation is over \$1 billion, says Heid, this restructuring wouldn't affect GSD.

GSD is hoping for a "yes" vote on the upcoming levy to be able to continue to operate and not have to make any drastic cuts in staff because of the inevitable cuts to be made.

The district is asking for a two cent increase to the

current levy of \$2.03 per thousand of property valuation.

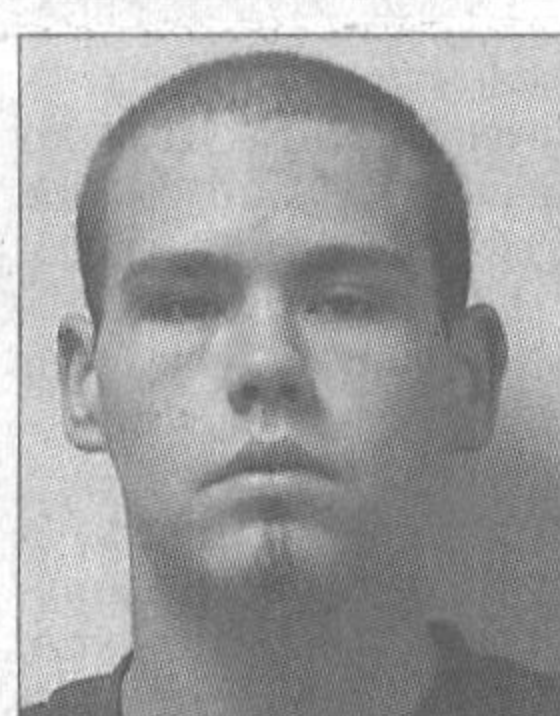
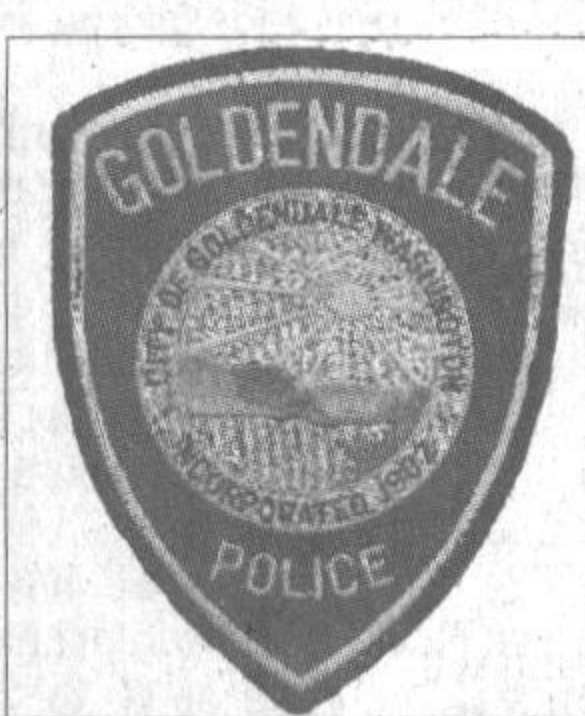
"That two cent increase will allow us to keep the staffing and the programs that we have in place," stated Heid.

He added, "I would hope that the parents would stand up and say, 'This is our kids' education.'"

One final worry that Heid has about the budget cuts is—"When does it stop?"

His concern is that the state will see that the district was able to compensate for the cuts with an increase in the levy, and will deal out more cuts in the coming years.

Everything is still up in the air and nothing has been decided by the legislation.

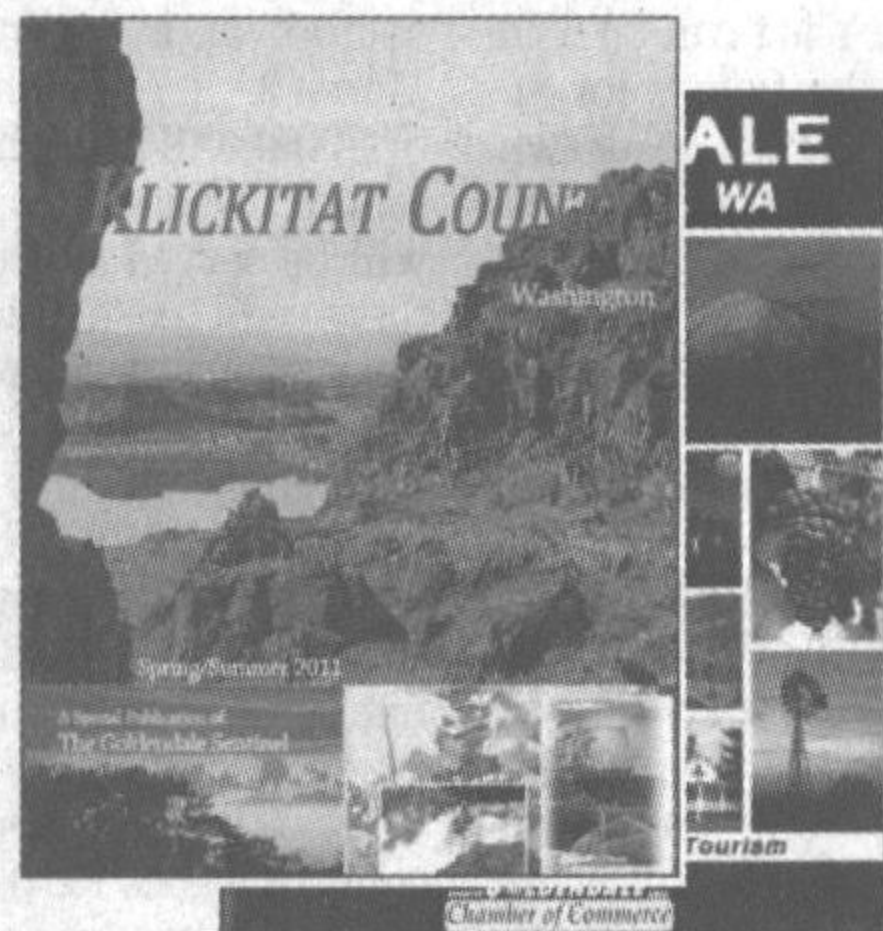

# Job growth soared in November - Dec. 14, 2011

Washington added an estimated 12,100 jobs in November, the largest one-month gain in four years.

The stronger jobs outlook was matched by a substantial plunge in the unemployment rate, from a revised rate of 9.1 percent in October to a preliminary estimate of 8.7 percent in November.

"This is the kind of job growth we need to make a good dent in the unemployment rate," said Greg Weeks, director of the Employment Security Department's labor-market information office. He added, "The drop in the unemployment rate was unusually large for November, and I

expect it to be revised to a somewhat smaller decline when we get more data."

In preliminary estimates, nearly every industry sector posted job gains last month.

These included professional & business services, an estimated increase of 4,200 jobs; leisure & hospitality, up 3,800; construction, up 2,000; transportation, warehousing & utilities, up 1,200; manufacturing, up 1,000 (including 1,100 in aerospace); financial activities, up 700; retail trade, up 600; mining & logging, up 200; wholesale trade, up 100;

information, up 100.

Jobs were lost in the other-services sector, down 1,300; education & health services, down 400; and government, down 100.

Within the government sector, state agencies lost an estimated 900 jobs, local government added 1,000, and the federal government lost approximately 200 jobs.

Altogether, employment in Washington has increased by an estimated 44,600 since November 2010.

An estimated 303,528 people (seasonally adjusted) in Washington were unemployed and looking for

work in October. As of Dec. 10, 67,588 workers in Washington had run out of all unemployment benefits.

Employment Security is a partner in the statewide WorkSource system, which offers a variety of employment and training services for job seekers, including free help with interviewing skills, résumés and job referrals. WorkSource also can help employers recruit and screen for qualified workers, apply for employment tax breaks and qualify for subsidized employee training.

# Unemployment-benefit extensions ending soon

Unemployed workers in Washington State are learning this week that their extended unemployment benefits will begin phasing out soon.

Currently, there are two federal programs operating in the state that pay additional weeks of unemployment benefits after eligible workers run out of their "regular" unemployment benefits: the "emergency unemployment compensation" program and the "extended benefits" program. The state Employment Security Department is informing participants by mail that both programs will begin shutting down over the next month.

"Employment Security is on the frontlines helping the unemployed, so we know how hard the loss of these benefits will be for thousands of families who rely on them," said Paul Trause, the state's employment security commissioner. "It's

particularly difficult to shut off benefits in the middle of winter, when there are fewer jobs available than in the summer."

The first program, emergency unemployment compensation (EUC), has been available since July 2008 and will begin phasing out at the end of Dec. EUC pays up to 53 weeks of benefits, in four tiers, after an individual has run out of "regular" benefits.

There are two dates that will affect whether existing claimants will continue to receive EUC benefits after the end of the year:

Individuals who run out of "regular" unemployment benefits no later than Dec. 24 may be eligible to advance to EUC tier 1 (which pays up to 20 weeks of benefits) if they apply before the end of December.

Anyone who establishes a EUC claim (in tiers 1, 2 or 3) by Dec. 31 may finish his or her existing tier,

but will not be able to advance to the next tier after this date. For example: an individual who is in week 10 of tier 1 at the end of December may claim up to 10 additional weeks of benefits, depending on the total amount of his or her benefit; however, the claimant will not be able to advance to EUC tier 2.

A second program, called "extended benefits," will likely end in mid- to late January in this state. The program pays up to 20 weeks of benefits to individuals who have run out of both regular and EUC benefits.

States can qualify for extended benefits based on a formula that is based mostly on their three-month average unemployment rate, which must be at least two percentage points higher than the same period in a previous year.

Under a temporary law, the state was allowed to compare the current

average to the average three years ago, when there was a much lower average unemployment rate. But the two-year look-back will be reinstated at the first of the year, and the difference will narrow to less than two percentage points.

Employment Security officials expect the change will cause the state to trigger off of extended benefits. Official word is expected from the federal Department of Labor by early Jan., and benefit payouts must end two weeks after that.

Currently, about 85,000 people are claiming EUC or extended benefits in Washington State. Another 108,000 are claiming regular unemployment benefits.

Congress is considering proposals to continue both the EUC and extended-benefits programs. If a bill passes, Employment Security will automatically notify all eligible individuals by mail.

The Women in Agriculture conference will be held on Saturday, February 11 and will broadcast two engaging speakers to 16 different locations throughout the state. The new localized format of the conference is designed to let farm women benefit from a statewide conference while still meeting their on-farm duties.

"Women are uniquely tasked with the demands of both farm and family, which can make travel to one

state location a challenge," said WSU Douglas County Extension Director and chair of the conference Margaret Viebrock. "This new approach allows us to offer our headline speakers at all locations, while also making the conference specific to each region."

Keynote speakers will be Lyn Garling, owner of Over the Moon Farm, and Rita Emmet, the author of "The Procrastinator's Handbook." Garling, a farmer who got started later in life, will share about being a "woman farmer" today and how her challenges, inspirations and frustrations have contributed to her success. Emmet will be detailing how to "Blast Away Procrastination" in order to be more successful at work, in relationships and in life. Emmet is a fun, persuasive speaker who argues that procrastination is not a character

trait, but simply a habit.

Garling and Emmet will be joined by local presenters who will talk about their risks and challenges with farming, including how to stay focused, keep current on market trends, the latest production methods and financial management.

Registration for the conference is \$25 and includes a copy of "The Procrastinator's Handbook", an opportunity to be listed in the conference brochure to increase networking opportunities, and lunch during the event. The deadline to register for the event is January 25 by mail or online. The conference is sponsored by the U.S. Department of Agriculture and the WSU Extension Western Center for Risk Management Education.

Women farmers and producers, supporting spouses and aspiring farmers are encouraged to attend. Agriculture students and farm interns are also welcome to participate.

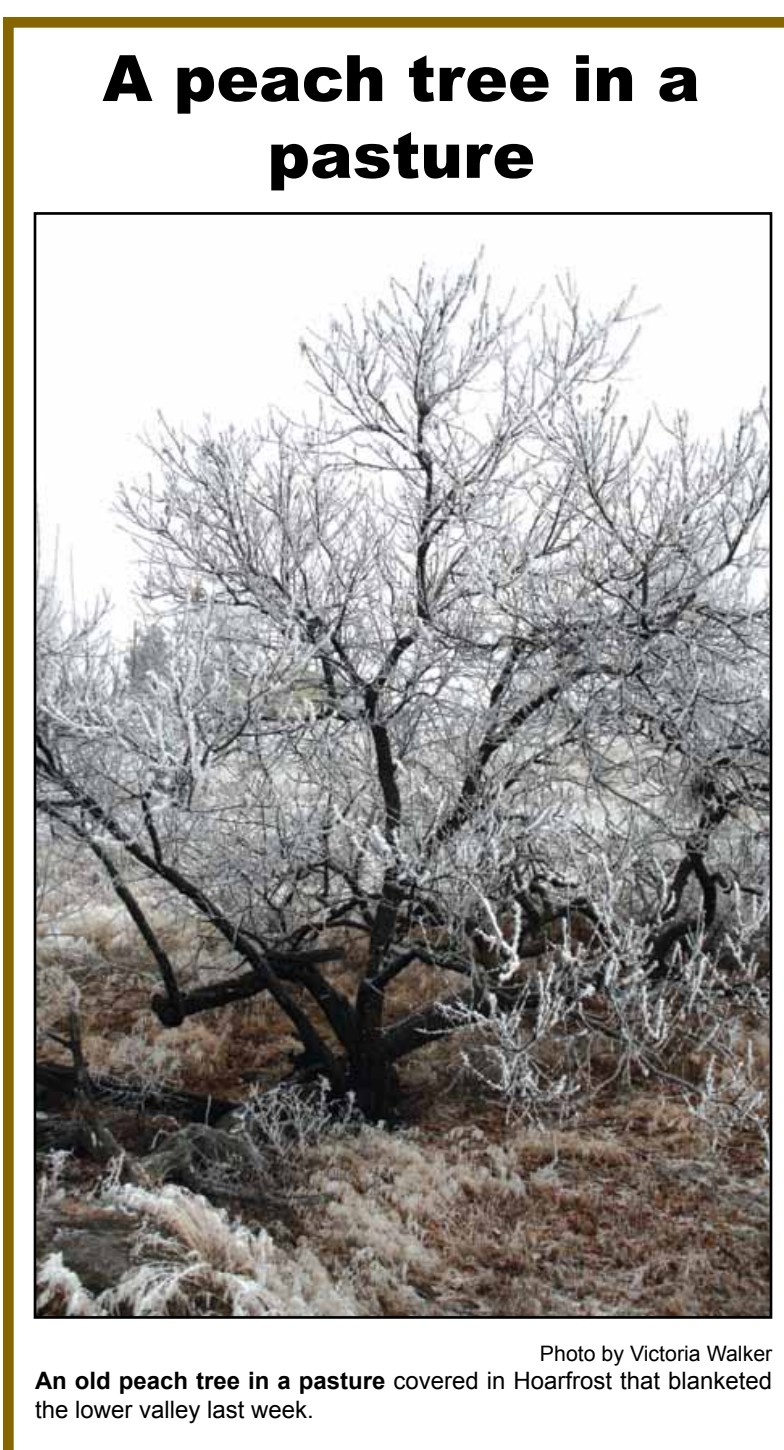

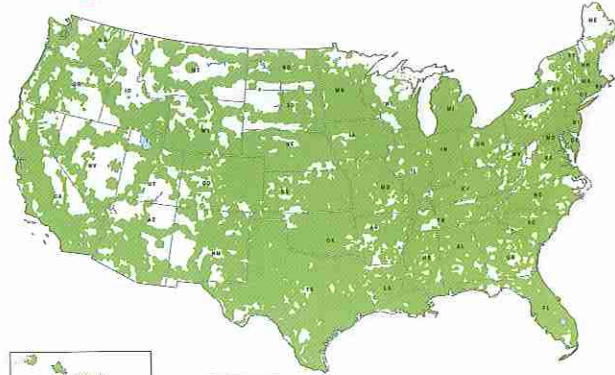
