Mr. Rupp, good morning.

T27N R10E, the Index-Galena road predates the National Forest, there is no formal easement there. The easement you have was granted for a major realignment and upgrade.

The road is a public highway and for management purposes is treated identically with segments under easement.

The Verizon Realty Division is in contact with Eric Ozog and we are working to get this utility proposal under Permit. As you may know, the Universal Access Fee on all our telephone bills is used to fund such utility projects to bring modern communications to remote areas. This is done regardless of revenue streams, a couple of years ago the Qwest folks spent 30 millions bringing fibre optic lines to Forks, on the Olympic peninsula, and a similar project brought telephone service to Silverton, just over the hill from you.

Mr. Shoemaker, Regarding the color swap in 10-27-10, county records show that the portion west of the river is state land, not private land. It's of no consequence to the utility easement issue of course, I'm just passing along some information that I thought you might like to know. More importantly, I got the easement document today, but the sections it identifies are all in Township 28 (see page 2 of the document) and are for portions of Index-Galena Rd to the north which are not included in our petition for a telephone line extension. My concern is for portions of Index-Galena Rd in sections all located in Townshop 27 (specifically 10 and 15 east of the river).
