COMES NOW Ryder Distribution Resources, Inc., (Ryder) and respectfully files this Petition for Intervention pursuant to WAC 480-09-430 with your Commission based upon the following grounds:

1. Ryder Distribution Resources' address is 3600 N.W. 82nd Avenue, Miami, Florida 33166.

2. Ryder is appearing through its counsel, Boyd Hartman, 11000 Main St., Bellevue, WA 98004.

Ryder holds temporary authority under the provisions of RCW 81.77.130 allowing it to transport Biohazardous or Biomedical Waste as a contract carrier for Stericycle, Inc., located at or near Morton, Washington. The territorial scope of its authority is set forth in Exhibit 1 attached hereto.


4. Ryder provides a garbage and refuse collection service as specifically limited by its authority, within the territory covered by the operations of Respondent transporting, under its contract authority, from the facilities of generators solicited by Respondent.

5. Ryder has pending a permanent application covering

the same service as evidenced in its temporary authority

6. Ryder has an interest in the issues to be litigated in this proceeding. Ryder requests that it be allowed to intervene in these proceedings and to participate in the examination of witnesses and the presentation of evidence. This intervention will not broaden the issue.
