NOTICE OF OPPORTUNITY TO FILE WRITTEN COMMENTS (By 5 p.m., Tuesday, September 21, 2021)

RE: Relating to the Commission's examination of energy decarbonization impacts and pathways for electric and gas utilities to meet state emissions targets,

TO ALL INTERESTED PERSONS:

In the 2021 operating budget, the Washington Utilities and Transportation Commission (Commission) received a state appropriation to "examine feasible and practical pathways for investor-owned electric and natural gas utilities to contribute their share to greenhouse gas emissions reductions as described in RCW 70A.45.020 [state law]." As part of its examination, the Commission must identify and consider the impacts of energy decarbonization on residential and commercial customers and electric and natural gas utilities. The results of the examination must be reported to the appropriate legislative committees by June 1, 2023.

To gather initial stakeholder input, the Commission held a public workshop on August 9, 2021, and accepted public comments through August 13, 2021. At the workshop, the Commission shared its intent to hire consulting services to support the Commission's examination. The Commission has written a draft request for proposals (RFP) to solicit qualified consultants. As described in the draft RFP, the solicitation is for an "on-call" contract. The Commission will select one bidder based on the experience of the consulting team, including any subconsultants, and the billable rates for consultant staff. Once the successful bidder is under contract, the Commission will work collaboratively with the consultant to develop one or more scopes of work. The on-call contract format is intended to allow the Commission and contractor to discuss an examination approach, as well as to scale tasks to the available budget and timeline.

Attachment A includes the substantive portions of the draft RFP for stakeholder consideration. Attachment A does not include standard contract language. In addition to the information
