**NOTICE MODIFYING PROCEDURAL SCHEDULE**

TO ALL PARTIES:

On March 13, 2023, the PacifiCorp d/b/a Pacific Power & Light Company (PacifiCorp or Company) filed a Revised Clean Energy Implementation Plan (Revised CEIP).

On May 18, 2023, the Commission issued Order 03, Prehearing Conference Order; Notice of Hearing, which established a procedural schedule including, among other things, a discovery deadline of October 20, 2023.

On June 28, 2023, the parties contacted the presiding administrative law judge to request that the Commission reschedule the Discovery Deadline to January 30, 2024, and indicated that all parties agreed to the change. Due to the parties' agreement, the Commission finds good cause to modify the current procedural schedule to accommodate the parties' agreed revised Discovery Deadline. The revised procedural schedule is attached hereto as Appendix A.
