Today I talked with Bruce Folsom of Avista. He had some clarifying questions about the intent of subsection 3 for prior customer notice for both gas/elec. proposed rules - I explained the intent and he was fine with the explanation. He also wanted to see if under subsection 5 a newsletter would work - as we discussed this I indicated that only if there is a bill message pointing customers to the important notice issues within the newsletter.

Also, under notice after commission action - he didn't understand staffs intent - the intent is to apply the newly approved price on the same bill along with a bill message explaining the increase in price.....

They are working on the informal comments and will file something with the commission prior to July 28. He asked for procedural update. I referred to Jim or Graciela.
