Thank you for the initial draft rules. Obviously quite a bit of work went into writing all those rules up. Please note the purpose of this email is not to provide feedback on those rules, but to request additional information.

There is some additional information that might help to increase our collective productivity. Jim Russell made a good suggestion on the phone yesterday. He thought it would be most productive if I email these to all of you on the cc list, so we all stay on the same page.

### Information Requested

It would be most helpful if the WUTC Staff could provide a brief paragraph/statement or two on each of the proposed rule revisions in the list below that identifies or explains the following:

- \* Please identify exactly what the language revision of each proposed rule is intended to change. If some revisions were intended only to clarify, identify those changes, too. It appears some draft rules contain multiple changes and multiple clarifications. Providing us with these statements will help us understand what the WUTC Staff is trying to accomplish, minimizing our confusion, and avoiding unnecessary contention.
- \* In each draft rule where changes from the current rules are intended (including new rules) please provide an explanation of why the WUTC Staff is proposing the change. This will help in two ways. First, by understanding the WUTC Staff's interest behind proposing each change we will understand why the change was proposed. Second, if any party has some reservations about the specific position proposed in the draft rules, we may be able to identify alternative solutions that meet all our interests.
