Dear Dr. Haar:

On February 27th, the Minnesota Public Utilities Commission ("Commission") issued an order in this matter that required CenturyLink to submit a failover plan on or before May 1st. The order also required the parties to attempt to negotiate regarding a voluntary transition of each competitive local exchange carrier (CLEC) to CenturyLink's Maintenance Tracking Gateway system (MTG).

CenturyLink, the Department of Commerce and the Joint CLECs have met by phone and in person on a number of occasions to meet both of these requirements. As a result of those discussions, CenturyLink and the Joint CLECs have agreed on the terms of a settlement agreement that not only addresses the transfer to MTG, but also resolves the CLEC need for third party testing and resolves complaint proceedings pending in Minnesota, Washington and Colorado.

While the terms of the agreement have been agreed upon, we need to obtain signatures and prepare a filing with the Commission explaining our settlement and seeking Commission approval. We expect to make that filing within the next week.

In the meantime, pursuant to ordering paragraph 1.D of the February 27th Order, the parties jointly request that the May 1 deadline for filing a failover and disaster recovery plan be delayed in order to give the Commission and the Department of Commerce the opportunity to review the settlement agreement.
