MEMORANDUM

- On December 31, 2018, Northwest Natural Gas, d/b/a NW Natural, (NW Natural or Company) filed with the Washington Utilities and Transportation Commission (Commission) revisions to its currently effective Tariff WN U-6, Natural Gas Service. The purpose of the Company's filing is to increase rates and charges for natural gas service provided to customers in the state of Washington.
- NW Natural also filed on December 31, 2018, a motion for standard protective order, requesting expedited treatment of the same. The Commission granted the motion and entered Order 02 Protective Order, on January 8, 2019. Order 02 provides safeguards for the distribution and retention of confidential information in this proceeding.
- On March 15, 2019, NW Natural filed an unopposed motion for amended protective order with highly confidential provisions (Motion), explaining that a recent information request seeks the production of highly sensitive financial forecasts, *i.e.*, highly confidential information. NW Natural asserts that if the requested information is released to current or potential counterparties or competitors, it could cause significant harm to NW Natural by providing competitors with a substantial advantage to NW Natural's financial detriment. NW Natural thus requests that the Commission issue a new protective order that includes "highly confidential" provisions.
- 4 NW Natural requests expedited consideration of the Motion and states that it has conferred with the other parties in this docket and none object to either the Motion or its expedited treatment.
