#### TO ALL INTERESTED PERSONS:

The Washington Utilities and Transportation Commission (Commission) proposes to adopt amendments to a portion of the rules in WAC Chapter 480-07, Procedural Rules. The Commission provides interested persons with the opportunity to file written comments on the proposed rule amendments and to participate in the formal rule adoption hearing scheduled for 9:30 a.m. on Monday, September 10, 2018.

On July 31, 2018, the Commission filed a Notice of Proposed Rulemaking (CR-102) with the Office of the Code Reviser. The proposed rules would revise the current rules governing confidential information in WAC Chapter 480-07 for greater clarity and better ensure appropriate protection for restricted information. The Commission has reviewed comments on draft rules from stakeholders and now proposes rules subject to review and comment by interested persons. The CR-102 filing initiates the final part of the rulemaking process, which includes a written comment period, a public adoption hearing, and a decision by the Commission.
