1	PROCEEDINGS
2	JUDGE CLARK: Good morning, it's
3	approximately 10:45, September 6, 2006, in Seattle,
4	Washington. This is the time and the place set for the
5	prehearing conference in Docket U-060273 In the Matter
6	of the Application of Avista Corporation for an Order
7	Approving a Corporation Reorganization to Create a
8	Holding Company, AVA Formation Corporation, Patricia
9	Clark, Administrative Law Judge for the Commission
10	presiding. The purpose of this morning's prehearing
11	conference is to establish a procedural schedule,
12	address discovery matters, and any other matter that
13	would aid in the efficient and expeditious resolution of
14	this case.
15	At this time I would like to take the
16	appearances of the parties. Appearing on behalf of
17	Avista?
18	MR. MEYER: Thank you, Your Honor. My name
19	is David Meyer, Vice President and Chief Counsel for

24	JUDGE CLARK: Appearing on behalf of Public

1	MS. KREBS: Yes, Judith Krebs, Assistant
2	Attorney General, and I'm appearing on behalf of the
3	Public Counsel Section of the Attorney General's Office,

13	JUDGE CLARK: Thank you.
14	Appearing on behalf of the Commission Staff.
15	MR. TROTTER: Thank you, Your Honor. My name
16	is Donald T. Trotter, Assistant Attorney General,
17	appearing for the Commission Staff, my address is 1400

22	JUDGE CLARK: Thank you, Mr. Trotter.
23	Is there anyone else who wishes to enter an
24	appearance this morning?
25	MR. PERKINS: Yes, thank you, Your Honor, for

the Industrial Customers of Northwest Utilities, I'm 1 Matthew Perkins from the law firm of Davison Van Cleve. 2 3 Also participating in this proceeding from our office 4 will be Brad Van Cleve, he's not here today though. Our address is 333 Southwest Taylor, Suite 400, Portland, 5 6 Oregon 97204, phone number is (503) 241-7242, fax number is (503) 241-8160, and our E-mail address is mail, 7 8 M-A-I-L, @dvclaw.com. 9 JUDGE CLARK: Thank you. Is it your 10 intention to enter a petition to intervene either orally 11 or written in this proceeding? 12 MR. PERKINS: Yes, Your Honor, we have 13 submitted a written petition to intervene previously, 14 I'm not sure of the exact date. 15 JUDGE CLARK: Thank you. 16 Anyone else wish to enter an appearance or submit an oral petition to intervene? 17 18 Is there any objection to the written petition to intervene submitted by Mr. Perkins' client? 19 20 MR. MEYER: There is no objection, Your 21 Honor. 22 JUDGE CLARK: All right, thank you. 23 Are there any preliminary matters that we need to address before we proceed to the procedural 24 25 schedule?

MR. MEYER: I would ask for a standard form
protective order.

3 JUDGE CLARK: All right, why don't we kind of 4 run through my list in order so I don't forget anything, 5 Mr. Meyer. Immediately before the prehearing conference 6 convened, the parties did have an opportunity to discuss 7 a procedural schedule. Would you like to memorialize 8 that for the record, Mr. Meyer.

9 MR. MEYER: I will be happy to do so, thank 10 you. The first date on the schedule would be a date for 11 filing of company direct, and that would be October 12 20th. Settlement conferences December 11th and 12th, 13 recognizing that that date may be somewhat fluid based 14 on other filings. Next date, Staff and Intervener 15 testimony, January 19th, 2007. Next date, Company 16 rebuttal and cross answering testimony of February 9th, 2007. Hearings February 26 through 28. Briefs March 17 18 23rd. And we had a suggested target date for an order, 19 but that was just for planning purposes, of April 23rd. 20 JUDGE CLARK: Is there anyone who wishes to 21 make any corrections or amendments to the schedule 22 proposed by Mr. Meyer? 23 All right.

24 MR. TROTTER: Excuse me, Your Honor, did he25 include cross answering testimony on February 9th?

1 JUDGE CLARK: Yes, he did. MR. TROTTER: Okay, thank you. 2 3 JUDGE CLARK: And I think it will be 4 necessary to also schedule a prehearing conference to mark exhibits in this proceeding or to address any other 5 6 procedural matters that might arise immediately preceding the hearing. The hearing is scheduled for the 7 28th, are the parties available on Monday the 26th? 8 9 MR. MEYER: Excuse me, Your Honor, I show for 10 the hearings themselves --11 JUDGE CLARK: Oh, I'm sorry, 26th through the 12 28th, I'm sorry, Friday the 23rd? 13 MR. MEYER: That would be fine with us. 14 JUDGE CLARK: All right. 15 (Discussion on the Bench.) 16 JUDGE CLARK: I have been advised that it probably would be recommended to schedule that 17 18 prehearing conference a little bit more in advance of the hearing than that, so I'm going to revise my 19 20 proposal to be February 22nd, are the parties available 21 on that date? 22 MR. MEYER: That's acceptable to the company. 23 JUDGE CLARK: All right. 24 Is that acceptable to everyone else? 25 MR. TROTTER: Yes.

1	JUDGE CLARK: All right.
2	And then now we can move along to the
3	protective order that you were discussing, Mr. Meyer.
4	MR. MEYER: Just request that a standard form
5	protective order issue in this docket.
6	JUDGE CLARK: All right. Does anyone wish to
7	be heard on that?
8	All right, how about discovery?
9	MR. TROTTER: We would ask that the discovery
10	rule be invoked.
11	JUDGE CLARK: All right, the discovery rules
12	will be invoked in this proceeding as well.
13	And I am advised by the records section of
14	the Commission that any documents that must be filed
15	with the Commission it's necessary to file an original
16	and 12 documents in this proceeding.
17	Are there any other matters that we need to
18	address during this morning's prehearing conference?
19	The record should also reflect that
20	Administrative Law Judge C. Robert Wallis is present for
21	this morning's prehearing conference and may well be
22	entering the prehearing order in this docket.
23	MR. TROTTER: Your Honor, the other issue was
24	whether there was a need for customer testimony, a
25	special hearing for customer testimony. Usually Public

Counsel weighs in on that issue, I just thought I would 1 2 put it on the table. 3 MS. KREBS: We will not be seeking a public 4 hearing in this case. 5 JUDGE CLARK: All right. 6 Any other matters? MR. MEYER: Just the same request that was 7 8 made in the earlier docket, which I thought was a good one, for additional people for electronic service, and I 9 10 have provided some Avista specific information in that 11 regard. 12 JUDGE CLARK: Right, let me just try to 13 quickly memorialize that agreement. In docket U-060518, 14 the parties agreed that they would submit a list of 15 individuals, that is staff and/or expert individual 16 witnesses who will be participating in the discovery 17 process. That list would be submitted to the 18 Administrative Law Judge and incorporated in the prehearing conference order and that to the extent 19 20 possible discovery responses and requests could be made 21 directly to those individuals as well as counsel in the 22 event counsel is unavailable in order to expedite the 23 discovery process. And I request that a similar list, if it is in any way different from the list submitted in 24 25 that proceeding, be submitted in this docket as well.

3	JUDGE CLARK: Anything further?
4	MR. PERKINS: Your Honor, I would just note
5	about the list that you just discussed, ICNU has not
б	submitted a petition to intervene in the other docket,
7	but I believe the people we would like to have discovery
8	and filing served on are noted in our petition to
9	intervene, so that can serve as our list.
10	JUDGE CLARK: All right, thank you.
11	Anything further?
12	Hearing nothing, we're adjourned.
