Dear Judge Haenle:

This letter is to confirm my oral request, made to you on July 17, 1990, for an extension of the time for filing briefs in the above proceeding for one week, from July 31, 1990, to August 7, 1990.

Prior to calling you, I attempted to reach Administrative Law Judge Lundstrom and Mr. Wolf, attorney for Shuttle Express. Both are away from their office this week.
