ORDER 01

GRANTING EXEMPTION FROM RULE

BACKGROUND

- On January 1, 20252, Co. 1(Avista or Company) filed with the Washington Utilities and Transportation Commission (Commission) a petition requesting an extension of the approval date of its draft all-source Request for Proposals (RFPs), which requires an exemption from Washington Administrative Code (WAC) 480-107-017(4) (Petition).
- WAC 480-100-NUM017(4) requires the Commission to "approve, approve with conditions, or suspend the filed RFP . . . within seventy-five days after the utility files its RFP."
- AvistaCo. 1 stated that, because of stakeholder comments received in Docket UE-210832 and a recently signed contract, the Company is preparing to file a revised 2022 All-Source RFP. The revised RFP will not be filed with sufficient time for Commission staff (Staff) and other stakeholders to review it prior to the end of the original 75 days, or by January 14, 2022, the date by which the Commission is required to act.
- The Company requests that the Commission take action to approve, approve with conditions, or suspend the revised RFP at the January 27, 2022, open meeting to allow sufficient time for stakeholder review.
- Staff has reviewed the Petition and recommends granting Avista Corporation's request to extend the approval date of the draft all-source request for proposals beyond January 14, 2022. Staff recommends the Commission hear this matter at its regularly scheduled open meeting on February 10, 2022, and that it grant the Company's Petition for exemption

subject to the condition that the revised RFP is filed on or before January 18, 2022.

DISCUSSION

- We agree with Staff's recommendation and grant Avista's request for an exemption from WAC 480-107-017(4) subject to the condition that the revised RFP is filed by January 18, 2022. Under WAC 480-107-002, the Commission may grant an exemption from the provisions of any rule from WAC 480-107 if doing so is consistent with the public interest, the purposes underlying regulation, and applicable statutes.
- WAC 480-107-017 outlines the RFP filing and approval process for utilities. As a matter of due process and transparency, the rules include an appropriate amount of time for public participation. We agree with Staff that Avista's request is reasonable to ensure that stakeholders have sufficient time to review the Company's revised RFP consistent with the spirit of the rule. Accordingly, we find that granting the Company's request for an exemption is in the public interest and consistent with both the purposes underlying the rule and applicable statutes. This matter will be heard at the Commission's regularly scheduled open meeting on February 10, 2022.

FINDINGS AND CONCLUSIONS

- 8 (1) The Commission is an agency of the State of Washington vested by statute with the authority to regulate the rates, rules, regulations, practices, accounts, securities, transfers of property and affiliated interests of public service companies, including electric companies.
- 9 (2) Avista is engaged in the business of providing electric services within the state of Washington and is a public service company subject to Commission jurisdiction.
- 10 (3) WAC 480-100-NUM017(4), requires the Commission to "approve, approve with conditions, or suspend the filed RFP . . . within seventy-five days after the utility files its RFP."
- Under WAC 480-107-002, the Commission may grant an exemption from the provisions of any rule in WAC 480-107 if doing so is consistent with the public interest, the purposes underlying regulation, and applicable statutes. See also WAC 480-07-110.

- 12 (5) This matter came before the Commission at its regularly scheduled meeting on January 13, 2022.
- 13 (6) After review of the Petition filed in Docket UE-210832 by Avista on January 1, 2025, and giving due consideration, the Commission finds that the exemption is in the public interest and is consistent with the purposes underlying the regulation and applicable statutes and should be granted, subject to the conditions in paragraph 6 above.

ORDER

THE COMMISSION ORDERS:

- 14 (1) Avista Corporation d/b/a Avista Utilities' Petition for an exemption from WAC 480-100-NUM017(4) is GRANTED, subject to the condition that Avista Corporation d/b/a Avista Utilities will file the revised RFP by January 18, 2022.
- The Commission will take action on the revised RFP at its regularly scheduled open meeting on February 10, 2022.
- The Commission retains jurisdiction over the subject matter and Avista Corporation d/b/a Avista Utilities to effectuate the provisions of this Order.
