JUSTIFICATION OF EXPENSES

3. One of the Tribe's outside attorneys, Andrew Fuller from Ogden Murphy Wallace, PLLC, spent 298.4 hours between July 3, 2023 and April 24, 2024, representing the Puyallup Tribe's interests with regard to case issues concerning the Tacoma Liquified Natural Gas facility (Tacoma LNG), which is consistent with the Tribe's proposed budget.² That work included, inter alia, document review, legal research, drafting filings in this case, and appearing on behalf of the Tribe at hearing. All of Mr. Fuller's time qualifies as expenses eligible for funding under a Fund Grant, as his time is "directly attributable to participation in the proceeding."³

COMPLIANCE WITH FUND GRANT

- 4. The Commission approved the Tribe's Proposed Budget after considering factors set forth in Section 6.5 of the Interim Agreement.⁴
- 5. The Commission also recognized that "[a]pproving the Puyallup Tribe's request for intervenor funding would be consistent with the legislature's intent to encourage participation from historically under-represented communities."⁵
- 6. The Tribe fully participated in this docket and provided a clear presentation of its positions on the issues before the Commission.
