BACKGROUND

I On March 22, 2002, the Washington Utilities and Transportation Commission (Commission) entered its Fifth Supplemental Order Approving and Adopting Settlement. The Fifth Supplemental Order resolved a complaint brought by the Commission alleging that Qwest had violated certain statutes and Commission rules related to Qwest's Centrex Customer Loyalty Program (CCLP).

In approving and adopting the settlement agreement reached by Staff and Qwest, the Commission penalized Qwest \$150,000 for failure to file an amendment to a customer's contract that gave the customer service credits under Qwest's unpublished CCLP. *Fifth Supplemental Order, Par. 7.* Of the \$150,000 penalty amount, \$100,000 was due and payable fifteen days after the Commission entered its order. The Commission suspended the remaining \$50,000 penalty amount for one year and provided that the amount would be mitigated to zero at that time if Qwest files a certification of compliance with applicable statutes and rules, and Staff has made no other allegations of violations relating to Qwest's Centrex services. *Id.*

- 3 On September 8, 2003, Quest filed the required certification. Qwest also states that to its knowledge Staff has made no other allegations of violations relating to Qwest's Centrex service.
- 4 Commission Staff has reviewed Qwest's certification and represents that it appears to comply in all substantive respects with the Commission's Fifth Supplemental Order. Moreover, Staff has made no other allegations of violations relating to Qwest's Centrex services.
- 5 The Commission finds that the certification filed with the Commission by Qwest on September 8, 2003, is consistent with Paragraph 7 of the Fifth Supplemental Order, and that Staff has made no other allegations of violations relating to Qwest's Centrex services. Accordingly, the remaining penalty amount of \$50,000 should be mitigated to zero.

ORDER

6 THE COMMISSION ORDERS That the remaining penalty amount of \$50,000 is mitigated to zero.
