NOTICE OF PROCEDURAL SCHEDULE REVISIONS

RE: *In the Matter of Determining the Proper Carrier Classification of Glacier Recycle, LLC; Hungry Buzzard Recovery, LLC; and T&T Recovery, Inc.*, Docket TG-072226

TO ALL PARTIES:

On January 28, 2008, the Washington Utilities and Transportation Commission (Commission) entered Order 02 – *Prehearing Conference Order* in this matter. Order 02 set out the procedural schedule for this docket, including a deadline of April 18, 2008, for the submission of dispositive motions.

On April 3, 2008, Commission Staff requested a one week continuance of each of the deadlines associated with the filing of dispositive motions in this matter. Staff's request stated that all parties had been informed and made no objection. Although Staff's request does not necessarily impact the filing dates for prefiled testimony, counsel for the respondents notes a reservation of the opportunity to request extension of those deadlines if the need arises.

Staff's request to extend the existing procedural schedule with regard to dispositive motions is granted. The request complies with the requirements in WAC 480-07-385 for such requests, and will not prejudice the parties or the Commission. The Commission revises the procedural schedule follows:
